In the morning, in Miami, FL, the President had an intelligence briefing. Later, he traveled to Allentown, PA, where, upon arrival, he met with USA Freedom Corps volunteer Cheryl Hornung.

In the afternoon, the President traveled to Manchester, NH, where, upon arrival, he met with USA Freedom Corps volunteer Paul Freeman. Later, at the McIntyre Ski Area in Manchester, he participated in a Victory 2004 rally.

The White House announced that on October 1 the President declared a major disaster in New Jersey and ordered Federal aid to supplement State and local recovery efforts in the area struck by Tropical Depression Ivan beginning on September 18 and continuing.

### October 3

During the day, the President participated in a debate preparation session.

### October 4

In the morning, the President had a telephone conversation with Prime Minister Silvio Berlusconi of Italy to congratulate him on the birth of his second grandson, to extend birthday

greetings, and to discuss the September 28 release of two Italian hostages held in Iraq. He then had an intelligence briefing.

Later in the morning, the President traveled to Des Moines, IA, where, upon arrival, he met with USA Freedom Corps volunteer Tony Salem.

In the afternoon, the President traveled to Clive, IA. Later, he returned to Washington, DC.

In the evening, in the Residence, the President watched the Vice Presidential debate. Later, he had a telephone conversation with Vice President Dick Cheney to discuss the debate.

#### *October 6*

The President declared a major disaster in South Carolina and ordered Federal aid to supplement State and local recovery efforts in the area struck by Tropical Storm Frances beginning on September 6 and continuing.

The President declared a major disaster in Minnesota and ordered Federal aid to supplement State and local recovery efforts in the area struck by severe storms and flooding beginning on September 14 and continuing.

The President declared a major disaster in the U.S. Virgin Islands and ordered Federal aid to supplement Territory and local recovery efforts in the area struck by Tropical Storm Jeanne on September 14–17.

The President declared a major disaster in Tennessee and ordered Federal aid to supplement State and local recovery efforts in the area struck by severe storms and flooding on September 16–20.

#### *October 8*

In the morning, the President had a telephone conversation with President-elect Susilo Bambang Yudhoyono of Indonesia to congratulate him on his October 4 election victory. He then had an intelligence briefing.

Later in the morning, in the Oval Office, the President received a telephone call from Democratic Presidential candidate John F. Kerry in which Senator Kerry conceded the November 2 election. During the call, the President expressed his appreciation for Senator Kerry's efforts in the campaign.

### *November 4*

In the morning, the President had a telephone conversation with President Khalifa bin Zayid Al Nuhayyan of the United Arab Emirates to express his condolences on the death of his father, former President Shaykh Zayid bin Sultan Al Nuhayyan. He then had a telephone conversation with President Hamid Karzai of Afghanistan to congratulate him on his October 9 election victory.

Later in the morning, the President had separate telephone conversations with Prime Minister Ariel Sharon of Israel, Prime Minister Ayad Allawi of the Iraqi Interim Government, President Aleksander Kwasniewski of Poland, President Vladimir Putin of Russia, and Prime Minister Silvio Berlusconi of Italy, all of whom congratulated the President on his reelection victory. He then had an intelligence briefing.

In the afternoon, on the State Floor, the President met with campaign staff to thank them for their efforts during the campaign. He then traveled to Camp David, MD.

The President announced the November 3 recess appointments of Carolyn L. Gallagher and Louis J. Giuliano as Governors on the Board of Governors of the U.S. Postal Service.

In the morning, the President had an intelligence briefing.

During the day, the President had a video conference with the National Security Council to discuss the situation in Fallujah, Iraq.

In the morning, the President had an intelligence briefing.

The White House announced that the President will welcome Prime Minister Tony Blair of the United Kingdom to the White House for discussions on November 11–12.

#### *November 7*

In the afternoon, the President and Mrs. Bush returned to Washington, DC.

#### *November 8*

In the morning, the President had an intelligence briefing. Later, in the Oval Office, he met with Secretary of Defense Donald H. Rumsfeld. He also had a telephone conversation with Prime Minister Junichiro Koizumi of Japan to discuss the situation in North Korea.

The White House announced that the President will meet with North Atlantic Treaty Organization Secretary General Jakob “Jaap” Gijsbert de Hoop Scheffer at the White House on November 10.

The White House announced that the President will attend the 12th Asia-Pacific Economic

Cooperation (APEC) Leaders’ Meeting in Santiago, Chile, on November 20–21 and later will participate in an official visit with President Ricardo Lagos of Chile.

#### *November 10*

In the morning, the President had separate telephone conversations with President Gloria Macapagal-Arroyo of the Philippines, Prime Minister Lee Hsien Loong of Singapore, Prime Minister Pedro Santana Lopes of Portugal, and King Abdullah II of Jordan, all of whom congratulated the President on his reelection victory.

Later in the morning, the President had an intelligence briefing and met with the National Security Council. He then met with Secretary of State Colin L. Powell.

During the day, the President met with Senator John McCain of Arizona to discuss legislative priorities.

#### *November 11*

In the morning, the President had an intelligence briefing. Later, on the State Floor, he hosted a reception for veterans, leaders of veterans organizations, and Medal of Honor recipients.

Later in the morning, the President and Mrs. Bush traveled to Arlington, VA, where they participated in a wreath-laying ceremony at the Tomb of the Unknowns in Arlington National Cemetery.

In the afternoon, the President and Mrs. Bush returned to Washington, DC.

During the day, the President had separate telephone conversations with President Jorge Batlle Ibanez of Uruguay, Prime Minister Ferenc Gyurcsany of Hungary, European Commission President Jose Manuel Durao Barroso, Prime Minister Kjell Magne Bondevik of Norway, and President Ahmet Necdet Sezer of Turkey, all of whom congratulated the President on his reelection victory.

In the afternoon, in the Old Family Dining Room, the President had a working lunch with Prime Minister Blair. Later, on the State Floor, the President met with members of the Republican National Committee and the Victory Committee to thank them for their efforts during the campaign.

During the day, the President had separate telephone conversations with President Vaclav Klaus of the Czech Republic, President Valdas Adamkus of Lithuania, and President Paul Kagame of Rwanda, all of whom congratulated the President on his reelection victory.

The White House announced that the President will travel to Cartagena, Colombia, to meet with President Alvaro Uribe of Colombia on November 22.

The White House announced that the President and Mrs. Bush will host King Juan Carlos I and Queen Sofia of Spain for a private luncheon in Crawford, TX, on November 24.
