

LIEUTENANT JOEL HARDAWAY—HEIRS OF.

Read, and ordered to lie on the table.

Mr. A. H. SHEPPERD, from the Committee on Revolutionary Claims, made the following

REPORT :

*The Committee on Revolutionary Claims, to which was referred the petition of the heirs of Joel Hardaway, deceased, report :*

That the petitioners claim commutation of five years' full pay, on account of the alleged revolutionary services of their ancestor, Joel Hardaway, deceased ; and, also, payment of the specie value of a warrant for fifteen thousand pounds, said to have issued in his favor for advancements made to the Government in 1787. The letter of the Third Auditor states that the records of the Pension Office show that Joel Hardaway was a lieutenant in the 4th South Carolina regiment, in the war of the Revolution ; but that they afford no evidence of the commencement or termination of his services. Various private memorandums are filed, purporting to show payments made by the said Hardaway, in the character of lieutenant during the revolutionary war, and coming down to 1782. No testimony is afforded to prove even the genuine character of these papers, which, at best, would afford but slight proof towards establishing the claim to commutation. The only foundation that is laid for the other branch of the claim consists of an alleged copy of a receipt, said to be signed by John Hopkins, assistant paymaster, with an endorsement by Nathaniel Lucas, stating that the original had been received by him in order to a final settlement ; and a letter purporting to be written by one Isaac Hicks, having reference to the delivery of this warrant to Mr. Lucas. The committee are of opinion that the character and extent of the testimony submitted to them do not justify the granting of relief under either branch of the claim set forth by the petitioners ; they therefore adopt the following resolution :

*Resolved,* That the prayer of the petitioners ought not to be granted.
