WAR DEPARTMENT,

*Pension Office, December 13, 1838.*

SIR: By a resolve of Congress (No. 7) which was passed on the 29th of May, 1830, it is made the duty of the Secretary of War to present, at each session of Congress, to the Senate and House of Representatives, a several list of such persons, whether revolutionary, invalid, or otherwise, as shall have made application for a pension, or an increase of pension, and as, in his opinion, ought to be placed upon the pension-roll, or otherwise provided for, and for doing which he has not sufficient power or authority; with the names and residence of such persons, the capacity in which they served, the degree of relief proposed, and a brief statement of the grounds thereof, to the end that Congress may consider the same.

As some difficulty arises as to the true interpretation of the resolution, it is deemed proper to state to you that all claims for pensions, when provided for by law and supported by the requisite proof, are admitted. Such

as are provided for by law, and are not substantiated by the necessary evidence, are not allowed, and the applicants are required to exhibit the usual testimony; and such claims as are not provided for by any act of Congress, are absolutely rejected.

Lists of claims rejected, marked A, B, C, D, and E, and which cannot, under any existing law, be admitted at this office, are herewith submitted to you, to the end that the object contemplated by the resolution may be effected.
