HEIRS OF GENERAL THOMAS SUMTER.

[To accompany bill H. R. No. 303.]

APRIL 4, 1840.

Mr. TALIAFERRO, from the Committee on Revolutionary Claims, made the following

REPORT:

The Committee on Revolutionary Claims, to whom was referred the petition of Thomas Sumter, report :

That the petitioner represents that his father, General Thomas Sumter. formerly of South Carolina, now deceased, who was a general officer of very distinguished reputation in the revolutionary war, not only gave his personal services to his country, in her great struggle for freedom and independence, but in the time of her utmost need loaned her a considerable sum of money, and received at the United States loan office in South Carolina, in evidence thereof, thirty-two certificates, of the nominal or paper-money value of one thousand dollars each—equal in specie to twenty five dollars each, or eight hundred dollars in all.

In the eventful life of General Sumter he lost or mislaid these certificates. Previous to his death he determined to apply to Congress for a special act for their payment, but sudden illness and death prevented his carrying his

purpose into effect.

Upon examination of the records of the Treasury Department, the committee find that on the 1st of June, 1780, nineteen certificates, and on the 17th October, 1780, thirteen certificates, as described by the memorialist, were issued from the United States loan office in South Carolina, to Thomas Sumter, and have never been redeemed or paid by the United States; of which fact an official certificate from the Treasury Department accompa-

nies this report. As these certificates were issued in the name of General Sumter, and asno other person has made application for payment thereof, or set up a claim to the same; and as they have never been redeemed by the United States, and are now outstanding on the books of the Treasury, and are a fair and legitimate debt due from the United States, the committee think they ought now to be paid to the legal representative of the estate of General Thomas Sumter; upon condition that a bond be given to refund the amount, or any part thereof, if any other person shall hereafter produce the certificates, or any of them, and prove a legal title to the same.

In accordance with this view, the committee report a bill.
