RECOMMENDING

That an appropriation be made to refund the amount paid to the navy yard at Gosport for repairs of the Norwegian bargue "Ellen."

SIR: I have the honor herewith to enclose two communications, addressed to the chairman of the Committee on Foreign Affairs and the chairman of the Committee of Ways and Means, respectively, recommending that an appropriation be made to refund to the viceconsul of Sweden and Norway at Norfolk, Virginia, the sum of \$749 92, paid by him to the United States navy yard at Gosport, in behalf of the captain and owners of the Norwegian barque Ellen, for repairs to that vessel on the occasion of her putting into the port of Norfolk to land passengers saved from the wreck of the steamer Central America. I will thank you to give these communications their appropriate direction.

VICE-CONSULATE OF SWEDEN AND NORWAY, Norfolk, Virginia, February 8, 1858.

SIR: I take the liberty of transmitting for the consideration of Congress the enclosed bill, paid by me to our navy yard here, amounting to \$749 92, for the partial repairs of the Norwegian barque Ellen, Captain A. Johnson, which vessel, in deviation of her voyage, put into this port to land the passengers so meritoriously saved from the wreck of the ill-fated steamer Central America.

On the arrival of said vessel in this port in her crippled condition, the department generously proffered every assistance, suggesting if the power were invested with them no charge would be made; but both they or the commodore not possessing the power, regular payment was demanded and promptly accorded. My aim is now in behalf of Captain Johnson and his owners, to get the same refunded, in which I am sure our worthy representative, John S. Wilson, esq., will give his hearty co-operation.
