FROM THE

PRESIDENT OF THE UNITED STATES.

TRANSMITTING

A communication from the Secretary of State, in response to a resolution of the House of Representatives, giving a list of promotions, removals, and appointments in the consular service since the 4th day of March, 1877.

MARCH 10, 1882.—Referred to the Committee on Foreign Affairs and ordered to be printed.

To the House of Representatives:

I transmit herewith, in answer to the resolution of the House of Representatives of the 30th of January last, a report from the Secretary of State, with accompanying papers.

WASHINGTON, March 10, 1882.

To the PRESIDENT:

The Secretary of State, to whom was referred the resolution of the House of Representatives of the 30th January last, requesting "a list of all promotions, removals, and appointments made in the consular service of the United States since the 4th day of March, 1877, stating particularly the names and residences of each person, with the date of his promotion, removal, or appointment, and upon whose recommendation such promotion, removal, and appointment were made," has the honor to transmit to the President such a list, to be sent to the House of Representatives, in response to such request.

The said resolution also asked information as to the reasons for such promotions, removals, and appointments. The Secretary of State, in response thereto, has the honor to say that the archives of this Department do not show the reasons.

The resolution also asks what changes have been made by transfer from one consular position to another, the date thereof, and the reasons therefor. The Secretary of State, in reply, has the honor further to say that the accompanying list gives the desired information in regard to

the transfers, except in regard to the reasons therefor, which the Secretary is unable to state, as the same does not appear in the archives of this Department.
