In these cases the court, on May 28, 1906, upon the motion of the attorneys for the Eastern Cherokees and in pursuance to a mandate of the Supreme Court, entered a decree modifying the original decree of May 18, 1905, and directing the Secretary of the Interior to prepare certain rolls of the Indians entitled to share in the judgment fund of \$1,111,-284.70, and fixing the compensation to be allowed the different attorneys for said Indians.
