STATEMENT OF CASE.

The claim in the above-entitled case for supplies, or stores, alleged to have been taken by or furnished to the military forces of the United States for their use during the late war for the suppression of the rebellion was transmitted to the court by the committee on War Claims of the House of Representatives the 23d day of April, 1890.

On a preliminary inquiry the court, on the 12th day of June, 1893, found that the person alleged to have furnished the supplies or stores, or from whom they were alleged to have been taken, was loyal to the Government of the United States throughout said war.

The case was brought to a hearing on its merits on the 24th day of March, 1897.

A. J. Willard, esq., appeared for claimant, and the Attorney-General, by Conway Robinson, esq., his assistant, and under his direction, appeared for the defense and protection of the interests of the United States.

The claimant in his petition makes the following allegations:

The following property belonging to William T. Bettis, deceased, was taken from him in Greene County, State of Missouri, on or about the 25th of October, 1862, by the forces of the United States, namely, the command under General Herron, to wit:

10 acres of corn, 40 bushels per acre, 400 bushels, at 50 cents per bushel..... \$200

The court, upon the evidence and after considering the briefs and arguments of counsel on both sides, makes the following

FINDING OF FACT.

The allegations of the petition are not sustained by the evidence.
