ORDER

Before **MATHESON**, **EID**, and **CARSON**, Circuit Judges.

Pro se Appellant Zacarias Moussaoui filed notices of appeal seeking to appeal magistrate judge's orders entered in 20 district court cases. The magistrate judge's orders directed Mr. Moussaoui to correct a pleading deficiency within 30 days by submitting a court-approved prisoner complaint form and a complete *in forma pauperis* (28 U.S.C.

§ 1915) application. The district judge has taken no action on the magistrate judge's orders and Mr. Moussaoui's 20 cases in the district court are ongoing. In the first three appeals filed in late September 2020, we entered orders to show cause why the appeals should not be dismissed for lack of jurisdiction because the magistrate judge's orders are not final and appealable orders. Mr. Moussaoui has filed responses. The next 17 appeals filed in early October 2020 suffer from the same jurisdictional defect and the court did not issue additional show cause orders. Upon consideration, we dismiss all 20 appeals for lack of jurisdiction.

This court generally has jurisdiction to review only final decisions of district courts. 28 U.S.C. § 1291; *see also Riley v. Kennedy*, 553 U.S. 406, 419 (2008) (describing final decisions as those that end the litigation on the merits and leave nothing for the court to do but execute the judgment). Orders entered by magistrate judges and not acted upon by the district court, such as the ones being appealed here, are not final and appealable. *See* 28 U.S.C. § 636(b)(1) (magistrate judge authority); *Phillips v. Beierwaltes*, 466 F.3d 1217, 1222 (10th Cir. 2006). And there is no recognized exception to the final judgment rule that applies to the orders being appealed. *See, e.g.*, 28 U.S.C. § 1292(a) (interlocutory decisions); *Cohen v. Beneficial Indus. Loan Corp.*, 337 U.S. 541 (1949).

Because the magistrate judge's orders directing Mr. Moussaoui to cure pleading deficiencies are not final and appealable orders, we lack jurisdiction to consider these 20 appeals.

All pending motions are denied as moot.
