ORDER

On November 9, 2022, this court concluded that the Prison Litigation Reform Act (PLRA) applied to each of the ten captioned appeals and ordered appellant Patrick M. Zimmer—on or before December 9, 2022—to prepay the entire filing fee in each of the ten appeals. *See* 28 U.S.C. § 1915(g); *Strope v. Cummings*, 653 F.3d 1271, 1273 (10th Cir. 2011); *Green v. Nottingham*, 90 F.3d 415, 418 (10th Cir. 1996). The court denied two motions for reconsideration Mr. Zimmer filed and reminded him that the fee remained due in each of the captioned appeals on or before December 9, 2022. These appeals are now before the court because Mr. Zimmer has not paid the appellate filing fee to the district court in any of the underlying actions. Accordingly, the court dismisses each of the captioned appeals for failure to prosecute. *See* 28 U.S.C. § 1915(g); 10th Cir. R. 3.3(B), 42.1.

A copy of this order shall stand as and for the mandate of the court in each of the captioned appeals.
