38 Anthony Antico appeals from a judgment of conviction entered in the United States
39 District Court for the Eastern District of New York (Amon, C.J.) after an anonymous jury found
40 him guilty of one count of participating in a racketeering enterprise and one count of illegal
41 gambling. Antico was sentenced principally to a term of 108 months' imprisonment. On appeal,

1 Antico challenges the sufficiency of the evidence supporting his conviction for racketeering, the
 2 District Court's decision to empanel an anonymous jury, and the procedural and substantive
 3 reasonableness of his sentence. We affirm.

 18 LOHIER, Circuit Judge:

19
 20 Anthony Antico appeals from a judgment of conviction entered after a jury trial in the
 21 United States District Court for the Eastern District of New York (Amon, C.J.), at which he was
 22 found guilty of one count of participating in a racketeering enterprise, in violation of 18 U.S.C. §
 23 1962(c), and one count of illegal gambling, in violation of 18 U.S.C. § 1955. On appeal, Antico
 24 challenges the District Court's decision to empanel an anonymous jury at trial, the sufficiency of
 25 the evidence underlying the racketeering conviction, and his sentence of 108 months'
 26 imprisonment on that count. We affirm.

27 BACKGROUND

28 Antico argues that there was insufficient evidence that he agreed in 2008 to extort money
 29 from or rob Mario Gulinello, who had won \$1.6 million on a "Pick Six" horse racing bet.
 30 Antico's participation in the conspiracy to rob Gulinello constituted one of the relevant predicate
 31 acts in the racketeering charge of which Antico was convicted. Because this is an appeal from a
 32 judgment of conviction entered after a jury trial, the following facts are drawn from the trial

1 evidence and described in the light most favorable to the Government. United States v. Bahel,
2 662 F.3d 610, 617 (2d Cir. 2011). We limit our recitation of the facts to those relevant to
3 Antico's sufficiency challenge.

4 Gulinello, the target of Antico's robbery conspiracy, became a millionaire in 2004. By
5 2008, one of Gulinello's acquaintances, Ralph Lento, had introduced him to Joseph Barrafato,
6 Jr., a ranking member of the Genovese crime family. In June 2008, Lento and Barrafato – a self-
7 described "made guy" involved in organized crime – met Gulinello at an off-track betting parlor
8 ("OTB") in the Bay Ridge section of Brooklyn. Barrafato asked Gulinello to join them for
9 coffee at a coffee shop a short drive away. With Gulinello in the back seat of their car, Lento
10 and Barrafato instead drove past the coffee shop to the Coney Island section of Brooklyn. After
11 reaching a particular Coney Island street, they slowed down and another car pulled up beside
12 them. At that point, Barrafato called out to the driver in the other car, "Hey, Tico, say hello to
13 my friend Mario." Gulinello's encounter with Antico, whose various aliases include "Tico" and
14 "Big Nose," lasted a few seconds. At trial Gulinello testified that Barrafato had previously
15 described Antico as a "good guy" recently released from jail. After the encounter, Gulinello
16 stopped frequenting the OTB parlor and returning Barrafato's telephone calls.

17 At or around the same time in 2008, Barrafato's telephone conversations were
18 intercepted by government agents via a court-authorized wiretap. In excerpts of several calls
19 from late June 2008 through July 2008 that were played for the jury, Barrafato and Antico
20 revealed their increasing financial difficulties, their familiarity with Gulinello's wealth, and their
21 eagerness to rob Gulinello with the help of accomplices.

1 On June 28, 2008, for example, in a telephone conversation recorded by the Government,
2 Barrafato and Lento discussed their financial worries, and Barrafato told Lento that “Big Nose”
3 had assured him that they would “have . . . money soon again.” On July 9, 2008, Antico urged
4 Barrafato to proceed quickly with a robbery that they had previously discussed, and Barrafato
5 specifically referred to a “house rob[bery]”:

6 ANTICO: . . . You gotta start movin’ around, my friend. . . .

7 . . .

8 BARRAFATO: I’m tryin’ to put a few things together, you
9 know? . . .

10 . . .

11 [W]hat are you, in OTB?

12 ANTICO: Nah, I’m home. . . .

13 . . .

14 Get that . . . guy[] to hang out with us!

15 BARRAFATO: [W]hich guy . . . the one I told you about, with
16 that thing?

17 ANTICO: Yeah, yeah. Ya gotta hang out with him.

18 BARRAFATO: . . . I gotta go a different route with him. . . .
19 Listen to me, it’s gotta be done the way I told
20 you

21 ANTICO: Yeah, right.

22 BARRAFATO: Yeah. It’s the only way!

23 . . .

24 Yeah, because these guys . . . , they would look
25 to house rob him. . . .

26 . . .

27 Yeah, yeah. I told them, “You, you don’t go
28 near there,” I told them.

29 ANTICO: That’s it.

1 BARRAFATO: . . . I said, "Back away from it," I told them. "If
2 there's anythin', I'm comin' to you," I told
3 them.

5 Appellant's Appendix ("App.") 59-60.

6 Two days later, on July 11, 2008, Barrafato and Antico spoke urgently again about that
7 "thing over there":

8 BARRAFATO: We're gonna come put . . . Yeah, I gotta . . .
9 We're puttin' somethin' together with that . . .
10 thing over there.

11 ANTICO: Oh! Alright.

12 BARRAFATO: Yeah. It's gonna be . . . We gotta do it. I, I
13 can't wait no more.

14 ANTICO: I know. Can't . . .

15 BARRAFATO: No.

16 ANTICO: . . . wait for it.

17 BARRAFATO: No, I can't wait. No, I need, just I need the
18 right ingredients to make the sauce, you know?

19 ANTICO: Right.

20 BARRAFATO: Yeah. That's the whole thing, it's the right
21 ingredients. I'm hurtin' myself right now. You
22 know what I'm sayin'? Yeah, exactly.

23 ANTICO: Alright.
24

25 App. 38-39.

26 On the evening of July 12, 2008, Barrafato discussed the proposed robbery in a series of
27 telephone conversations with Antico, Lento, and Frank Martino, another associate of the
28 Genovese crime family. During the first call, at 8:09 p.m., Barrafato spoke with Martino about
29 the possibility of recruiting "Paulie" for the robbery of a "Pick 6" winner. Barrafato described
30 the Pick 6 winner as a "millionaire" with whom "Paulie" was acquainted:

1 BARRAFATO: [Y]ou know a kid Paulie with a skin head? He's
2 got a bald head?

3 MARTINO: Paulie? Yeah.

4 BARRAFATO: OK. Uh . . . there's somethin' uh . . . We gotta
5 get . . . I, when, when I see you, I'll talk to you.

6 MARTINO: OK.

7 BARRAFATO: Yeah. We . . . And uh, this, this thing here
8 could go down . . . 'Cause I rather talk to you in
9 person, you know?

10 . . .

11 [H]e could help us with somethin' where we
12 could uh . . .

13 MARTINO: Oh, yeah?

14 . . .

15 BARRAFATO: Yeah, yeah. Well . . . And he stays with a guy
16 that's a millionaire. Do you understand? And
17 uh . . . But we can't let him know. Capisce?

18 MARTINO: Right.

19 BARRAFATO: You just gotta, 'cause you just gotta get him to,
20 to us.

21 MARTINO: He's, he's always got, he's always got those type
22 of guys hangin' around him, all the time. . . .

23 BARRAFATO: Ye- Yeah, the guy . . .

24 MARTINO: Huh?

25 BARRAFATO: This is the guy that hit the Pick 6 for a million
26 point six. He hit the Pick 6 . . .

27 MARTINO: He did?

28 BARRAFATO: . . . yeah, a cou-, a few years back.

29

30 App. 42-44. Antico does not suggest that "the guy that hit the Pick 6" refers to anyone but

31 Gulinello.

1 After explaining that Paulie could be enlisted to help rob Gulinello, Barrafato told
2 Martino that he personally knew the target of the robbery:

3 MARTINO: [S]o what could this kid [Paulie] do for you?

4 BARRAFATO: Well, I, I said I'll tell you when I see you how
5 we gotta go for, for us. You know what I'm
6 sayin'? Wi-with this. Where we could put
7 maybe 20 in our pockets.

8 . . .

9 I got the, listen, I got the guy. I know where the
10 guy lives. I got, I got everythin' on him. But I
11 sayin, uh . . .

12 MARTINO: Right.

13 BARRAFATO: [H]e knows, you know, he knows me, you
14 know?

15 App. 44-45.

16 Barrafato spoke with Antico at 9:02 p.m. on July 12, 2008, less than an hour after
17 speaking with Martino about robbing Gulinello:

18 BARRAFATO: Oh, I've been, been runnin' around tryin' to put
19 things together, you know?

20 ANTICO: And you got it together?

21 BARRAFATO: We're gonna, we're gonna do, we're gonna, uh,
22 do it this week.

23 ANTICO: With those, with those guys?

24 BARRAFATO: With . . . No, no. Somebody else. Me and
25 somebody else.

26 ANTICO: Are you gonna . . . ? They're gonna do it?
27 They're gonna do it . . . ?

28 BARRAFATO: I, I, I wanna go, I wanna go over it with you be-,
29 you know, before.

30 ANTICO: Alright.

31 . . .

1 BARRAFATO: I'll talk to you uh, maybe uh, Monday or, you
2 know . . . ?

3 ANTICO: You, you got it.
4

5 App. 65.

6 Four minutes later, at 9:06 p.m., Barrafato called Lento, who previously had helped
7 Barrafato drive Gulinello to Coney Island to meet Antico. Barrafato urged Lento to make
8 himself "available" that week for "somethin', somethin' good." Barrafato explained that he had
9 spoken to Frankie Martino and that the participants would consist of "me, you, him [Martino]
10 and we need one more guy, that's all. But a good guy." Barrafato informed Lento that he also
11 had spoken to Antico about his plans: "And I, I just spoke to Big Nose and uh . . . I guess, he's
12 gonna talk to Frankie [Martino] before, but you are down on it You and somebody else."
13 Addressing their financial woes, Barrafato added, "We're now . . . at least we'll get ourselves
14 above water." App. 49-50.

15 Three days later, on July 15, 2008, Barrafato told Antico that he had done his
16 "homework" and "leg work" to prepare, and that he had "been over" and would be able to do "it"
17 during "the weekend":

18 BARRAFATO: . . . I want you to – I told you to take care of that
19 thing, that thing. You know.

20 ANTICO: Yeah?

21 BARRAFATO: What I was tellin' you? Yeah, we did a lit- . . .
22 we did a little leg work.

23 ANTICO: Huh?

24 BARRAFATO: We did some leg work on it, you know?

25 ANTICO: Yeah, uh-huh.

26 BARRAFATO: Yeah, yeah. We've been over We're
27 gonna it do [sic] uh . . . the weekend.

1 ANTICO: Oh, yeah?

2 BARRAFATO: Yeah. We did the leg work, you know? . . .

3 ANTICO: Yeah, yeah.

4 BARRAFATO: Yeah, you gotta, you gotta do your homework.

5 ANTICO: All right.

6

7 App. 53.

8

9 Barrafato and Antico spoke again by telephone the following afternoon, on July 16, 2008.

10 During the same conversation, Antico specifically mentioned a plan to “rob somebody,” while

11 Barrafato suggested that they speak in person rather than by phone after he had “everything

12 prepared”:

13 BARRAFATO: What’s doin’, buddy?

14 ANTICO: You’re gonna rob anybody or just, you, you
15 know . . . ? Hello?

16 BARRAFATO: Yeah, yeah, yeah.

17 ANTICO: Yeah. What happened?

18 BARRAFATO: All right. Uh . . . I’m gonna go out and do a
19 couple things . . .

20 . . .

21 Yeah, and uh . . . We’ll, we’ll get everything
22 prepared and uh, then, uh, I wanna touch base
23 with you. Like, you know . . .

24 ANTICO: Go ahead.

25 BARRAFATO: . . . I would like to see you in person, you
26 know?

27 ANTICO: Go ahead. Don’t worry . . .

28 BARRAFATO: I wanna, I wanna tell you . . . Yeah.

29 ANTICO: . . . too much.

1 App. 56. Barrafato and Antico are heard laughing after Antico said, “You gonna rob anybody.”

2 The following day, July 17, 2008, a federal law enforcement agent visited Barrafato at home, and
3 the conspiracy to rob Gulinello ended.

4 2. Procedural History

5 Antico was charged in a five-count superseding indictment (the “Indictment”). Count
6 One, which is most relevant to this appeal, charged him with conducting or participating in the
7 conduct of a racketeering enterprise in violation of 18 U.S.C. § 1962(c), based on four predicate
8 acts, any two of which would support a conviction of racketeering conspiracy. Two of the
9 predicate acts were (1) a conspiracy to extort money from Gulinello, in violation of New York
10 Penal Law §§ 155.40(2) and 105.10, or to rob Gulinello, in violation of New York Penal Law §§
11 160.10(1) and 105.10, and (2) illegal gambling, in violation of 18 U.S.C. § 1955. The remaining
12 counts charged Antico with illegal gambling, robbery conspiracy, attempted robbery, and using
13 and carrying a firearm in furtherance of a crime of violence.

14 At trial, the District Court empaneled an anonymous jury.¹ Before doing so, the court
15 noted Antico’s prior federal conviction in the United States District Court for the Eastern District
16 of New York for “racketeering with predicate acts of extortion and witness tampering.” The
17 District Court also considered “the seriousness of the charges, the lengthy prison sentences that
18 convictions would entail, the evidence of Antico’s efforts to interfere with the judicial process,
19 and the ability of the defendant to enlist the resources of the Genovese crime family.”

¹ The District Court employed a modified voir dire in which prospective jurors completed a detailed questionnaire, but their names, addresses, and workplaces were not disclosed to Antico.

Antico was convicted of Count One based on (1) his participation in a conspiracy to extort money from or rob Gulinello, and (2) illegal gambling. The jury also convicted Antico of a separate count of illegal gambling but acquitted him of the remaining counts against him. In November 2010 the District Court sentenced Antico principally to 108 months' imprisonment on the racketeering conviction.² In imposing sentence, the District Court relied in part on testimony from a cooperating witness at trial, Salvatore Maniscalco, that Antico recruited him to rob Louis Antonelli, a jeweler, of \$300,000 in jewelry and \$200,000 in cash. According to Maniscalco, the robbery was botched and resulted in Antonelli's death. Antico had been acquitted at trial of charges of robbery conspiracy and attempted robbery in connection with this scheme.

DISCUSSION

1. Sufficiency of the Evidence

Antico argues that there was insufficient evidence that he agreed to extort money from or rob Gulinello, which constituted one of the relevant predicate acts in the racketeering charge.³ A defendant who challenges the sufficiency of the evidence after a conviction "bears a heavy burden," United States v. Desnoyers, 637 F.3d 105, 109 (2d Cir. 2011) (quotation marks omitted), and we "view[] the evidence in the light most favorable to the prosecution," United States v. Heras, 609 F.3d 101, 105 (2d Cir. 2010) (quotation mark omitted). Under this "exceedingly deferential standard of review," United States v. Hassan, 578 F.3d 108, 126 (2d Cir. 2008), we will affirm the conviction if "any rational trier of fact could have found the

² The District Court also imposed a term of sixty months' imprisonment on the conviction for illegal gambling, to run concurrently with the 108-month sentence imposed for Count One.

³ Antico does not dispute that sufficient evidence existed to support the jury's finding that he participated in illegal gambling, which constituted one of the predicate acts in Count One.

1 essential elements of the crime beyond a reasonable doubt,” Heras, 609 F.3d at 105 (quotation
2 mark omitted).

3 Under New York law, a person is guilty of conspiracy in the fourth degree “when, with
4 intent that conduct constituting . . . a class B or class C felony be performed, he or she agrees
5 with one or more persons to engage in or cause the performance of such conduct.” N.Y. Penal
6 Law § 105.10(1). A conspiracy charge “require[s] the government to prove, beyond a reasonable
7 doubt, that the defendant knew the specific nature of the conspiracy or underlying crime. Proof
8 that the defendant knew that some crime would be committed is not enough.” United States v.
9 Friedman, 300 F.3d 111, 124 (2d Cir. 2002) (citations omitted). N.Y. Penal Law § 160.10(1)
10 provides that a person is guilty of robbery in the second degree, a class C felony, when “he
11 forcibly steals property” and is “aided by another person actually present.” N.Y. Penal Law §
12 160.10(1). To “forcibly steal[]” means to “use[] or threaten[] the immediate use of physical
13 force upon another person,” N.Y. Penal Law § 160.00, though “[t]he threatened use of force
14 may be implicit . . . when viewed under the totality of facts.” People v. Lopez, 555 N.Y.S.2d
15 444, 445 (App. Div. 2d Dep’t 1990).

16 “The traditional deference accorded to a jury’s verdict is especially important when
17 reviewing a conviction for conspiracy . . . because a conspiracy by its very nature is a secretive
18 operation, and it is a rare case where all aspects of a conspiracy can be laid bare in court with the
19 precision of a surgeon’s scalpel.” United States v. Jackson, 335 F.3d 170, 180 (2d Cir. 2003)
20 (alteration in original) (quotation marks omitted). Further, in a conspiracy case, as in any other,
21 “the government is entitled to prove its case solely through circumstantial evidence.” United
22 States v. Rodriguez, 392 F.3d 539, 544 (2d Cir. 2004). To the extent that the Government relies

1 on circumstantial evidence of a defendant's participation in a conspiracy, however, we have
2 cautioned that such

3 circumstantial evidence of knowledge and specific intent sufficient
4 to sustain a conviction must include some indicia of the specific
5 elements of the underlying crime, such as proof of a defendant's
6 knowledge or intent through evidence that the defendant
7 participated in conversations directly related to the substance of
8 the conspiracy, . . . proof that a defendant exercised authority
9 within the conspiracy itself, . . . or a defendant's statements
10 explicitly confirming the nature of the activity in which the
11 co-conspirators were engaged.

12
13 Friedman, 300 F.3d at 126 (quotation marks and brackets omitted).

14 Particularly when viewed in chronological order, the recorded telephone conversations
15 involving Barrafato, Lento, Martino and Antico constitute circumstantial evidence that the group
16 planned together to rob Gulinello. See App. 29 (Barrafato informing Lento on June 28, 2008
17 that "Big Nose" said they'd both have money soon); App. 59 (Antico telling Barrafato on July 9
18 to "start movin' around"); App. 38-39 (Barrafato telling Antico on July 11, "We're puttin'
19 somethin' together with that . . . thing over there."); App. 42-44 (Barrafato discussing with
20 Martino on July 12 the possible recruitment of "Paulie" to help get "maybe 20" from "the guy
21 that hit the Pick Six for a million point six"); App. 65 (Barrafato telling Antico on July 12,
22 "[W]e're gonna, uh, do it this week," stating that he wanted to "go over it with" Antico
23 beforehand, and Antico agreeing); App. 49-50 (Barrafato enlisting Lento on July 12 to work with
24 him and Martino on a matter that he previously discussed with Antico).

25 The Government also introduced direct evidence of Antico's involvement in the
26 conspiracy to rob Gulinello. During the recorded conversation between Antico and Barrafato on
27 July 16, 2008, Antico specifically asked, "You're gonna rob anybody?" App. 56. Barrafato

1 responded, “Yeah, yeah, yeah,” and both laughed. While it may be true, as Antico maintains,
2 that one interpretation of this conversation is that Antico and Barrafato were joking, a rational
3 juror also could reasonably have viewed the conversation as referencing Barrafato’s delays in
4 robbing Gulinello and reflecting the two men’s agreement to rob Gulinello within the meaning of
5 New York Penal Law §§ 160.10(1) and 105.10(1). See United States v. Torres, 604 F.3d 58, 67
6 (2d Cir. 2010) (“[W]e defer to a jury’s assessments with respect to credibility and conflicting
7 testimony, and to its choice between the competing inferences that can be drawn from the
8 evidence . . .”). Indeed, the evidence adduced at trial included another telephone conversation
9 in which Barrafato and Antico referred to a “house rob[bery]” without a hint of laughter. See
10 App. 59-60 (Barrafato telling Antico on July 9 that “those guys . . . would look to house rob
11 him,” but that Barrafato instructed them not to “go near there”).

12 In light of the prior recorded conversations between Barrafato and Antico from late June
13 through July 12, 2008, the jury could infer that this last telephone exchange on July 16 reflected
14 Antico’s instruction to rob Gulinello, followed by Barrafato’s affirmative agreement to commit
15 the robbery with the help of other accomplices. See United States v. Rosenblatt, 554 F.2d 36, 38
16 (2d Cir. 1977). The jury could similarly infer that the planned robbery would involve at least an
17 implicit threat of force based on the “totality of facts” presented, see Lopez, 555 N.Y.S.2d at
18 445, including (1) the use of the word “rob,” the ordinary meaning of which includes the threat
19 of force, see Webster’s Third New International Dictionary 1964 (2002) (listing first definition
20 of “rob” as “to take something away from (a person) by force”), (2) the fact that Barrafato
21 recruited three other men to participate in the robbery, and (3) the Coney Island car ride, which
22 appears to have been designed to intimidate Gulinello.

1 In sum, viewing the circumstantial and direct evidence in the light most favorable to the
2 Government, and evaluating that evidence “not in isolation but in conjunction,” Torres, 604 F.3d
3 at 67 (quotation marks omitted), we conclude that there was sufficient evidence adduced at trial
4 of Antico’s knowing participation in the conspiracy to rob Gulinello in June and July 2008 to
5 sustain the racketeering conspiracy conviction.

6 2. The Anonymous Jury

7 Antico challenges the District Court’s decision to empanel an anonymous jury both on
8 constitutional grounds and because he contends it abused its discretion in doing so. We have
9 made clear that “when genuinely called for and when properly used, anonymous juries do not
10 infringe a defendant’s constitutional rights.” United States v. Quinones, 511 F.3d 289, 295 (2d
11 Cir. 2007) (quoting United States v. Thai, 29 F.3d 785, 800 (2d Cir. 1994)) (quotation marks
12 omitted); see also United States v. Vario, 943 F.2d 236, 239 (2d Cir. 1991). Accordingly, we
13 have explained that “a court may order the empaneling of an anonymous jury upon (a)
14 concluding that there is strong reason to believe the jury needs protection, and (b) taking
15 reasonable precautions to minimize any prejudicial effects on the defendant and to ensure that
16 his fundamental rights are protected. Within these parameters, the decision whether or not to
17 empanel an anonymous jury is left to the district court’s discretion.” United States v. Gotti, 459
18 F.3d 296, 345 (2d Cir. 2006) (citation and quotation marks omitted). As relevant here, the first
19 requirement may be satisfied by a “demonstrable history or likelihood of obstruction of justice
20 on the part of the defendant or others acting on his behalf.” Vario, 943 F.2d at 241.

21 With these well-established principles in mind, we reject Antico’s challenge to the
22 District Court’s empanelment of an anonymous jury. The District Court acted well within its

1 discretion when it determined, based on Antico's history of jury tampering and other factors, that
2 the additional protection provided by jury anonymity was warranted. Quinones, 511 F.3d at 295
3 ("We have identified strong reasons to believe that a jury needed protection in situations where
4 the government demonstrated a defendant's willingness to tamper with the judicial process.").
5 In addition, the District Court took reasonable precautions to minimize any prejudice to Antico
6 and to ensure that his fundamental rights were not undermined by the decision to empanel an
7 anonymous jury. Those precautions included providing the jurors with a neutral explanation of
8 the reasons for which certain measures would be taken during trial and ordering that prospective
9 jurors be given a detailed questionnaire, drafted with input from defense counsel.

10 3. Challenge to Antico's Sentence

11 Antico also challenges the District Court's decision at sentencing to rely on evidence of
12 Antico's participation in the conspiracy to rob Antonelli, the jeweler, as relevant conduct under
13 Section 1B1.3 of the United States Sentencing Guidelines, despite Antico's acquittal on that
14 charge. Although this finding resulted in a substantial increase in Antico's total offense level
15 under the Guidelines, from 28 to 43, the District Court ultimately imposed a sentence – 108
16 months' imprisonment – that represented a substantial downward variance from the applicable
17 Guidelines range, based on a recognition that Antico had been acquitted of the relevant conduct.
18 Nevertheless, Antico argues that the District Court erred in relying on the conduct.

19 A district court may treat acquitted conduct as relevant conduct at sentencing, provided
20 that it finds by a preponderance of the evidence that the defendant committed the conduct.
21 United States v. Watts, 519 U.S. 148, 156 (1997). Findings of relevant conduct are reviewed for
22 clear error. See United States v. Skys, 637 F.3d 146, 152, 155 (2d Cir. 2011). The District
23 Court did not clearly err in finding by a preponderance of the evidence that Antico was involved

1 in the plan to rob Antonelli. In finding that the conspiracy to rob Antonelli qualified as relevant
2 conduct, the District Court was entitled to, and did, credit Maniscalco's testimony that Antico
3 was involved in the plan to rob Antonelli and recruited Maniscalco to execute it. Moreover, the
4 District Court explicitly "decline[d] to impose a sentence at the level called for by the guidelines
5 . . . based on a finding made by a preponderance of the evidence," and stated that Antico "was
6 convicted of less serious offenses, and it is for those offenses that he is and should be
7 sentenced."

8 Having concluded that Antico's sentence is procedurally reasonable, we next consider
9 whether the sentence is substantively reasonable. Antico principally submits that his 108-month
10 sentence was substantively unreasonable given the "low level" nature of the crimes of which he
11 was convicted, his age (75), the fact that he is currently serving a separate term of imprisonment
12 for a racketeering conviction, and the District Court's partial reliance on the Antonelli robbery,
13 of which Antico was acquitted. Even assuming that some of these factors militate slightly in
14 Antico's favor, the District Court was entitled to conclude that all of the remaining factors
15 warranted a higher sentence. In any event, as we have already observed, the 108-month sentence
16 represented a significant downward variance from the applicable Guidelines range. We therefore
17 reject Antico's challenge to the substantive reasonableness of his sentence.

18 CONCLUSION

19 We have considered Antico's remaining arguments and conclude that they are without
20 merit. For the foregoing reasons, we AFFIRM the judgment of the District Court.
