PER CURIAM:

Jamohn A. Neal appeals the district court's order adopting the magistrate judge's recommendation and denying relief on his civil action asserting claims under the Federal Tort Claims Act, and *Bivens v. Six Unknown Named Agents of Fed. Bureau of Narcotics*, 403 U.S. 388 (1971). We have reviewed the record included on appeal and find no reversible error.
