PER CURIAM.

Pursuant to 28 U.S.C. § 1441, Evelyn Wallace removed to federal court an action involving real property. The district court¹ remanded the case to the state court, and Wallace appeals. We lack jurisdiction to review the remand order. See 28 U.S.C. § 1447(d) (order remanding case to state court from which it was removed is not reviewable on appeal, unless case “was removed pursuant to section 1443”); 28

U.S.C. § 1443 (allowing removal of civil-rights cases). Accordingly, we dismiss the appeal.
