29 **STIPULATION**

30 WHEREAS, on or about June 20, 2014, Plaintiffs commenced an action in
31 the Superior Court of the State of California, County of Solano, entitled *David*
32 *Estep, et al. v. Yuen Yung, et al.*, bearing Case No. FCS 043717 (the “Complaint”);

33 WHEREAS, Defendants Yuen Yung and HDYR, LLC removed the
34 Complaint from the Superior Court to this Court on October 15, 2014;

1 WHEREAS, this Court issued an Order Requiring Joint Status Report (Doc.
2 2) requiring: “Within sixty (60) days of service of the complaint on any party, or
3 from the date of removal, the parties shall confer as required by Fed. R. Civ. P.
4 26(f) and shall prepare and submit to the Court a joint status report that includes
5 the Rule 26(f) discovery plan.”;

6 WHEREAS, 60 days after October 15, 2014 is December 14, 2014;

7 WHEREAS, Defendants Yung and HDYR, LLC filed a Motion to Transfer,
8 or, Alternatively, Dismiss, Plaintiffs’ Complaint (“Motion to Transfer”) on
9 October 21, 2014 (Doc. 4);

10 WHEREAS, the hearing for the Motion to Transfer was set for December 4,
11 2014;

12 WHEREAS, the Court has moved the hearing for the Motion to Transfer
13 from December 4, 2014 to December 18, 2014 (Doc. 9);

14 WHEREAS, it is the mutual intention of the parties to engage in a Rule 26(f)
15 conference, but request that the conference be held after the Court rules on the
16 Motion to Transfer because (1) waiting will ensure compliance with any Local
17 Rules in the event that the case is transferred and (2) the Rule 26(f) conference
18 would be addressed differently if Yung is dismissed;

19 **IT IS HEREBY STIPULATED BETWEEN THE PARTIES**, by and
20 through counsel, to request that this Court extend the deadline to submit a joint
21 status report from 60 days to 90 days, thereby requiring a joint status report on or
22 before January 13, 2015.
