26 **STIPULATION**

27 The defendant was temporarily released on conditions to receive medical care, and
28 a status conference was set before Magistrate Judge Claire for an update on his progress
for May 31, 2022. This date was continued to June 29, 2022. The parties are requesting
to continue the status conference again to August 10, 2022.

29 Since being released, Mr. Gowans has reinstated his health insurance, received and
30 is taking his previously prescribed medication. He was awaiting approval from health
31 insurance carrier to see his specialist at Sutter Health, Dr. Peterson. In the meantime, Mr.
32 Gowans has completed a physician's appointment scheduled for June 17, 2022, in Vallejo.

1 He has received approval to see his specialist, Dr. Petersen, and has an appointed scheduled
2 on July 5, 2022, to see him.

3 The parties stipulate and jointly request that the status conference scheduled before
4 Magistrate Judge Claire on June 29, 2022, be continued to August 10, 2022, at 10:00 a.m.
5 and that the defendant continue to temporarily remain out of custody until that date and
6 time.
