27 Defendant: MICHAEL HAMPTON, through his attorney, PETER KMETO
28 and the United States of America, through its counsel of record, CAMERON L.
29 DESMOND, stipulate and agree to the following:

30
31 1—On June 1, 2021 Michael Hampton was released from federal
32 custody on case #2:21-CR-00104 TLN under special conditions which included
33 the following:

34
35 Condition #3. You must reside in the halfway house located at 111 Taylor
36 Street and you must comply with all conditions of that facility;

37
38 Condition # 4. You must remain at the halfway house at all times except for
39 employment, education, religious services, medical, substance abuse, or mental

1 health treatment, attorney visits, court appearances, court-ordered obligations, or
2 other activities approved in advance by Pretrial Services;

3 2—To date, Michael Hampton has been compliant with these terms
4 and Pretrial Services has received no reports of complaint regarding Mr.
5 Hampton;

6 3—The Taylor Street half-way house has a program entitled “Social
7 Pass” where it allows participants to meet with relatives of the participants
8 outside the facility for up to 8 hours (9:00 a.m. to 5:00 p.m.) in order to maintain
9 familial ties. Advanced approval by Pretrial Services is required;

10 4—Under Special Condition number 4, the “Social Pass” activity
11 would qualify as “other activity”;

12 5—The family members Michael Hampton would be authorized to meet
with are:

13 --Miyah Hampton: daughter
14 --Michelle Hampton: daughter
15 --Michaela Hampton: daughter
16 --Brittany Holmes Hampton: daughter
17 --Mikel Hampton: daughter

18 Stipulation:

19 Accordingly, the parties further stipulate that Pretrial Services, under the exercise
20 of their sound discretion, allow defendant, Michael Hampton to participate in the Taylor
21 Street “Social Pass” activity defined as: social passes allowed and approved by the

1 halfway house; in order to maintain ties with the above named daughters of Michael
2 Hampton.


