**STIPULATION AND ORDER  
CONFIRMING ATTORNEYS' FEES  
AND COSTS FOR THE FOURTH  
QUARTER OF 2020**

Judge: Hon. Deborah Barnes

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly  
2 Statement for the Fourth Quarter of 2020 to Defendants via e-mail on February 10, 2021.  
3 The parties completed their meet and confer process on March 5, 2021. The parties have  
4 resolved all disputes regarding fees and costs for the Fourth Quarter of 2020, with an  
5 agreement to reduce claimed amounts to a total of \$907,722.30 calculated at a rate of  
6 \$223.50 per hour pursuant to 42 U.S.C.A. § 1997e(d)(3).

7 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that  
8 \$907,722.30 plus interest is due and collectable as of forty-five days from the date of entry  
9 of this Order. Interest on these fees and costs will run from March 13, 2021 (31 days after  
10 Defendants' receipt of Plaintiffs' statement), accruing at the rate provided by 28 U.S.C.  
11 § 1961.
