27 **STIPULATION AND ORDER RE:  
EXTENSION OF TIME TO MEET AND  
CONFER ON PARALEGAL AND NON-  
PARALEGAL FEE RATES**

28 On August 30, 2010, the parties stipulated that they would meet and confer regarding the  
nonparalegal rate issue, as well as the paralegal rate issue, within 10 days after the mandate issued  
in the *Perez v. Cate* appeal in the U.S. Court of Appeals for the Ninth Circuit. (Docket No. 3906)  
That mandate issued on February 4, 2011, and thus the deadline for the parties to meet and confer  
is February 14, 2011. The parties, by and through their counsel, stipulate as follows:

29 1. The parties shall have up to and including Tuesday, February 22, 2011, to meet  
30 and confer regarding the nonparalegal and paralegal rate issues in *Coleman*. If the parties are still  
31 unable to resolve this issue, plaintiffs will re-file a motion to compel within 60 days of the
