CONFIRMING ATTORNEYS' FEES  
AND COSTS FOR THE FIRST  
QUARTER OF 2015**

Judge: Hon. Dale A. Drozd

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly  
2 Statement for the First Quarter of 2015 to Defendants via overnight delivery on April 28,  
3 2015. The parties completed their meet and confer process on June 1, 2015. The parties  
4 have resolved all disputes regarding fees and costs for the First Quarter of 2015, with an  
5 agreement to reduce claimed amounts to a total of \$558,122.82.

6 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that
