CONFIRMING ATTORNEYS' FEES  
AND COSTS FOR THE SECOND  
QUARTER OF 2015**

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly  
2 Statement for the Second Quarter of 2015 to Defendants via overnight delivery on July 27,  
3 2015. The parties completed their meet and confer process on August 26, 2015. The  
4 parties have resolved all disputes regarding fees and costs for the Second Quarter of 2015,  
5 with an agreement to reduce claimed amounts to a total of \$473,266.75.

6 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that  
7 \$473,266.75 plus interest is due and collectable as of forty-five days from the date of entry  
8 of this Order. Interest on these fees and costs will run from August 29, 2015 (31 days after  
9 Defendants' receipt of Plaintiffs' statement), accruing at the rate provided by 28 U.S.C.  
10 § 1961.


