11 CONFIRMING ATTORNEYS' FEES
12 AND COSTS FOR THE FOURTH

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly
2 Statement for the Fourth Quarter of 2015 to Defendants via overnight delivery on January
3 28, 2016. The parties completed their meet and confer process on March 4, 2016. The
4 parties have resolved all disputes regarding fees and costs for the Fourth Quarter of 2015,
5 with an agreement to reduce claimed amounts to a total of \$405,382.31.

6 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that
7 \$405,382.31 plus interest is due and collectable as of forty-five days from the date of entry
8 of this Order. Interest on these fees and costs will run from February 29, 2016 (31 days
9 after Defendants' receipt of Plaintiffs' statement), accruing at the rate provided by 28
10 U.S.C. § 1961.
