12 CONFIRMING ATTORNEYS' FEES
13 AND COSTS FOR THE THIRD
14 QUARTER OF 2016**

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly
2 Statement for the Third Quarter of 2016 to Defendants via overnight delivery on
3 October 27, 2016. The parties completed their meet and confer process on December 14,
4 2016. The parties have resolved all disputes regarding fees and costs for the Third Quarter
5 of 2016, with an agreement to reduce claimed amounts to a total of \$594,602.07.

6 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that
7 \$594,602.07 plus interest is due and collectable as of forty-five days from the date of entry
8 of this Order. Interest on these fees and costs will run from November 28, 2016 (31 days
9 after Defendants' receipt of Plaintiffs' statement), accruing at the rate provided by 28
10 U.S.C. § 1961.
