

1 Whereas, on September 27, 2013, Kirby Morgan Dive Systems, Inc. (“Kirby
2 Morgan”) filed a Motion for Leave to File First Amended Counterclaims and Amend
3 Scheduling Order (the “Motion”), i.e. *see* Docket Entry No. 47;

5 Whereas, on December 5, 2013, the Court granted Kirby Morgan’s Motion,
6 ordering that the amended counterclaims be filed within 10 days of the date of the

10 Counterclaims, i.e. *see* Docket Entry No. 75;

12 Whereas, the First Amended Counterclaims add new parties, Heliox, Inc.
13 (“Heliox”), a California corporation, and Jason Van der Schyff (“Van der Schyff”), an
14 individual residing in California;

16 Whereas, on December 17, 2013, John I. Alioto, Esq., presently counsel for
17 Surface Supplied, Inc., indicated to Kirby Morgan’s counsel, Daniel M. Cislo, Esq.,
18 that he and Tony P. Cascio, Esq., also presently counsel for Surface Supplied in this
19 action, would be representing Heliox and Van der Schyff and that they were authorized
20 to accept service of the First Amended Counterclaims on behalf of Heliox and Van der
21 Schyff;

23 Whereas, on December 17, 2013, counsel for the parties agreed that Heliox and
24 Van der Schyff would waive service of process in this action;

26 Whereas, on December 17, 2013, counsel for the parties agreed that, due to the
27 upcoming holidays, Heliox and Van der Schyff’s responsive pleading to Kirby
28 Morgan’s First Amended Counterclaims would be due on January 27, 2014;
