The Parties agree that the Infringing Materials should be destroyed, but only after (1) the final conclusion of the above-captioned matter, including the final conclusion of all available appeals of this matter, (2) the final conclusion of any related investigation of Defendants by any governmental agency or authority, and, (3) the final conclusion, including all available appeals, of any litigation that is currently pending or that may arise and that may implicate the Infringing Materials in Defendants' possession, where Oracle or any Defendant is a party, including but not limited to Oracle's lawsuit against Rimini Street pending in the United States District Court, District of Nevada, Case No. 2:10-cv-0106-LRH-PAL (the "Other Litigation").

NOW, THEREFORE, THE PARTIES HEREBY STIPULATE AS FOLLOWS:

Pursuant to 17 U.S.C. § 503, Defendants shall, at their own expense, destroy all Infringing Materials within their possession, custody, and/or control within 90 days after all three of the following events have occurred: (1) the final conclusion of the above-captioned matter, including the final conclusion of all available appeals of this matter; (2) the final conclusion of any related investigation of Defendants by any governmental agency or authority; and, (3) the final conclusion of the Other Litigation, including the final conclusion of all available appeals of the Other Litigation.
