On September 7, 2007 at 9:00 a.m. in Department 6 of the above-entitled Court, Petitioner, MARK HAWKE, by and through his counsel, David J. The Petition was filed July 21, 2007 pursuant to California Penal Code § 1326 and the Sixth Amendment to the United States Constitution.

11 any kind related to LUCIA HERRERA HAWKE's (aka LUCIA HERRERA MARQUEZ)  
12 allegations of domestic violence against MARK HAWKE lodged with the United States of  
13 America, or any governmental entity operating on its behalf, from January 1, 2004 to the date of  
14 production under case number A97879961.

15          4.       Any and all correspondence sent from the U.S. Department of Homeland  
16 Security, Immigration and Citizenship Services to LUCIA HERRERA HAWKE (aka LUCIA  
17 HERRERA MARQUEZ), or an authorized agent on her behalf, from January 1, 2004 to the date  
18 of production under case number A97879961.

19          5.       Any and all correspondence sent from LUCIA HERRERA HAWKE (aka LUCIA  
20 HERRERA MARQUEZ), or an authorized agent on her behalf, to U.S. Department of Homeland  
21 Security, Immigration and Citizenship Services from January 1, 2004 to the date of production  
22 under case number A97879961.

23               This Order shall be served on the office of the Chief Counsel, U.S. Department of  
24 Homeland Security, all parties to the State Court proceedings and Lucia Herrera Hawke (aka  
25 Lucia Herrera Marquez).
