MEMORANDUM TO THE UNITED STATES SUPREME COURT FOR THE MONTH OF NOVEMBER, 1974

On 11/14/74, argued November 21, 1974—Decided June 2, 1975.

After reviewing broadcasting company, KATL had been refused permission to interview and take photographs at a prison. KATL petitioned for a writ of habeas corpus which a federal court granted. Respondent sought to have the writ vacated, arguing that the writ was issued in violation of 42 U.S.C. § 1983 against a person who supervised the jail. During argument of the case, the Supreme Court noted that the petition presented a question of whether the writ was issued in violation of the public hearing requirements of parts of the jail that are not hearing areas. Various other questions were raised on the merits, but were not argued or decided. Because, including members of the media, who have a presence at the jail would not have been. The Justice Court preliminarily rejected petition from denying KATL had presented and requested more specific information regarding whether or not the jail, including its hearing areas, had been preventing their using photographs or audio equipment or from conducting inside interviews. The Court of Appeals affirmed. Held: The judgment is reversed and the case is remanded. 511 U.S. 1114.

511 U.S. 1114, reversed and remanded.

The Court further noted by Mr. Justice Warren and Mr. Justice Brennan, concluded that neither the First Amendment nor the Fourteenth Amendment provides a right of access to governmental information.
