CONCURRENT RESOLUTION

Authorizing the use of the Capitol Grounds for the seventeenth annual National Peace Officers' Memorial Service.

- 1 Resolved by the House of Representatives (the Senate
- 2 concurring),

1 SECTION 1. USE OF CAPITOL GROUNDS FOR NATIONAL

- 2 PEACE OFFICERS' MEMORIAL SERVICE.
- 3 The National Fraternal Order of Police and its auxil-
- 4 iary shall be permitted to sponsor a public event, the sev-
- 5 enteenth annual National Peace Officers' Memorial Serv-
- 6 ice, on the Capitol Grounds on May 15, 1998, or on such
- 7 other date as the Speaker of the House of Representatives
- 8 and the Committee on Rules and Administration of the
- 9 Senate may jointly designate, in order to honor the more
- 10 than 160 law enforcement officers who died in the line
- 11 of duty during 1997.

12 SEC. 2. TERMS AND CONDITIONS.

- 13 (a) In General.—The event authorized to be con-
- 14 ducted on the Capitol Grounds under section 1 shall be
- 15 free of admission charge to the public and arranged not
- 16 to interfere with the needs of Congress, under conditions
- 17 to be prescribed by the Architect of the Capitol and the
- 18 Capitol Police Board.
- 19 (b) Expenses and Liabilities.—The National
- 20 Fraternal Order of Police and its auxiliary shall assume
- 21 full responsibility for all expenses and liabilities incident
- 22 to all activities associated with the event.

23 SEC. 3. EVENT PREPARATIONS.

- 24 (a) STRUCTURES AND EQUIPMENT.—Subject to the
- 25 approval of the Architect of the Capitol, the National Fra-
- 26 ternal Order of Police and its auxiliary are authorized to

- 1 erect upon the Capitol Grounds such stage, sound amplifi-
- 2 cation devices, and other related structures and equip-
- 3 ment, as may be required for the event authorized to be
- 4 conducted on the Capitol Grounds under section 1.
- 5 (b) ADDITIONAL ARRANGEMENTS.—The Architect of
- 6 the Capitol and the Capitol Police Board are authorized
- 7 to make any such additional arrangements as may be re-
- 8 quired to carry out the event.

9 SEC. 4. APPLICABILITY OF PROHIBITIONS.

- Nothing in this resolution may be construed to waive
- 11 the applicability of the prohibitions established by section
- 12 4 of the Act of July 31, 1946 (40 U.S.C. 193d; 60 Stat.
- 13 718), concerning sales, displays, and solicitations on the
- 14 Capitol Grounds.
