JOINT RESOLUTION

Granting the consent and approval of Congress for the State of Maryland, the Commonwealth of Virginia, and the District of Columbia to amend the Washington Metropolitan Area Transit Regulation Compact.

Whereas the State of Maryland, the Commonwealth of Virginia, and the District of Columbia have adopted amendments to the Washington Metropolitan Area Transit Reg-

ulation Compact relating to public hearing requirements and empowering transit police officers to carry weapons issued by WMATA while in an off-duty status, consistent with limitations imposed by the applicable political subdivision; and

Whereas the Congress has reviewed such amendments and is willing to consent to such amendments: Now, therefore, be it

- 2 of the United States of America in Congress assembled,
- 3 That consent of Congress is hereby given to the amend-
- 4 ments of the State of Maryland (Chapter 489, 1996 Laws
- 5 of the Maryland General Assembly and Chapters 91 and
- 6 699, 1997 Laws of the Maryland General Assembly), the
- 7 amendments of the Commonwealth of Virginia (Chapter
- 8 150, 1995 Acts of Assembly of Virginia), and the amend-
- 9 ments of the District of Columbia (D.C. Law 11-443) to
- 10 sections 62 and 76 of title III of the Washington Metro-
- 11 politan Area Transit Regulation Compact. Such amend-
- 12 ments are as follows:
- 13 (1) Section 62(a) is amended to read as follows:
- 14 "(a) The Board shall not raise any fare or rate, nor
- 15 implement a major service reduction, except after holding
- 16 a public hearing with respect thereto.".
- 17 (2) Section 62(c) is amended to read as follows:
- 18 "(c) The Board shall give at least fifteen days' notice
- 19 for all public hearings. The notice shall be given by publi-

- 1 cation in a newspaper of daily circulation throughout the
- 2 Transit Zone and such notice shall be published once a
- 3 week for two successive weeks. The notice period shall
- 4 start with the first day of publication. Notices of public
- 5 hearings shall be posted in accordance with regulations
- 6 promulgated by the Board.".
- 7 (3) Section 76(b) is amended to read as follows:
- 8 "(b) A member of the Metro Transit Police shall have
- 9 the same powers, including the power of arrest, and shall
- 10 be subject to the same limitations, including regulatory
- 11 limitations, in the performance of his duties as a member
- 12 of the duly constituted police force of the political subdivi-
- 13 sion in which the Metro Transit Police member is engaged
- 14 in the performance of his duties. A member of the Metro
- 15 Transit Police is authorized to carry and use only such
- 16 weapons, including handguns, as are issued by the Author-
- 17 ity. A member of the Metro Transit Police is subject to
- 18 such additional limitations in the use of weapons as are
- 19 imposed on the duly constituted police force for the politi-
- 20 cal subdivision in which he is engaged in the performance
- 21 of his duties.".
- 22 (4) Section 76(e) is amended to read as follows:
- "(e) The Authority shall have the power to adopt
- 24 rules and regulations for the safe, convenient, and orderly
- 25 use of the transit facilities owned, controlled, or operated

by the Authority, including the payment and the manner of the payment of fares or charges therefor, the protection 3 of the transit facilities, the control of traffic and parking 4 upon the transit facilities, and the safety and protection of the riding public. In the event that any such rules and regulations contravene the laws, ordinances, rules, or reg-6 ulations of a signatory or any political subdivision thereof 8 which are existing or subsequently enacted, these laws, ordinances, rules, or regulations of the signatory or the po-10 litical subdivision shall apply and the conflicting rule or regulation, or portion thereof, of the Authority shall be 12 void within the jurisdiction of that signatory or political subdivision. In all other respects, the rules and regulations of the Authority shall be uniform throughout the Transit 14 15 Zone. The rules or regulations established under this subsection shall be adopted by the Board following public 16 hearings held in accordance with section 62(c) and (d) of 18 this Compact. The final regulation shall be published in 19 a newspaper of general circulation within the Zone at least 20 15 days before its effective date. Any person violating any 21 rule or regulation of the Authority shall be subject to arrest and, upon conviction by a court of competent jurisdic-23 tion, shall pay a fine of not more than two hundred fifty dollars (\$250) and costs. Criminal violations of any rule or regulation of the Authority shall be prosecuted by the

- 1 signatory or political subdivision in which the violation oc-
- 2 curred, in the same manner by which violations of law,
- 3 ordinances, rules, and regulations of the signatory or polit-
- 4 ical subdivisions are prosecuted.".
