A BILL

To amend the Goals 2000: Educate America Act to restore opportunity-to-learn standards.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Opportunity-to-Learn
- 5 Standards Implementation Act".
- 6 SEC. 2. GOALS 2000: EDUCATE AMERICA ACT.
- 7 (a) References.—Except as otherwise expressly
- 8 provided, whenever in this section an amendment or repeal
- 9 is expressed in terms of an amendment to, or repeal of,

1	a title, chapter, part, subpart, section, subsection, or other
2	provision, the reference shall be considered to be made to
3	a title, chapter, part, subpart, section, subsection, or other
4	provision of the Goals 2000: Educate America Act (20
5	U.S.C. 5801 et seq.).
6	(b) Opportunity-To-Learn Development
7	Grant.—The Act is amended—
8	(1) by redesignating parts B and C as parts C
9	and D, respectively; and
10	(2) by inserting after part A the following:
11	"PART B—OPPORTUNITY-TO-LEARN

6	"(2) Composition of Consortia.—To the ex-
7	tent possible, each consortium shall include the par-
8	ticipation of—
9	"(A) State-level policymakers, such as Gov-
10	ernors, State legislators, chief State school offi-
11	cers, and State school board members;
12	"(B) local policymakers and administra-
13	tors, such as local school board members, su-
14	perintendents, and principals;
15	"(C) teachers (especially teachers involved
16	in the development of content standards) and
17	related services personnel;
18	"(D) parents and individuals with experi-
19	ence in promoting parental involvement in edu-
20	cation;
21	"(E) representatives of business;
22	"(F) experts in vocational-technical edu-
23	cation;
24	"(G) representatives of regional accrediting
25	associations;

1	"(H) individuals with expertise in school fi-
2	nance and equity, the education of at-risk stu-
3	dents, and the preparation and training of
4	teachers and school administrators;
5	"(I) curriculum and school reform experts;
6	"(J) representatives of advocacy groups,
7	including student and civil rights advocacy
8	groups;
9	"(K) representatives of higher education;
10	and
11	"(L) secondary school students.
12	"(3) Duties of Consortia.—In developing
13	voluntary national opportunity-to-learn standards,
14	each consortium shall—
15	"(A) draw upon current research about
16	student achievement and the necessary condi-
17	tions for effective teaching and learning; and
18	"(B) provide for the development of more
19	than one draft of standards which incorporate
20	the comments and recommendations of edu-
21	cators and other knowledgeable individuals
22	across the Nation.
23	"(4) Expertise or background.—One-third
24	of the members of each consortium shall consist of
25	individuals with expertise or background in the edu-

- 1 cational needs and assessment of children who are
- 2 from low-income families, are from minority back-
- grounds, have limited-English proficiency, or have
- 4 disabilities.
- 5 "(5) GEOGRAPHIC REPRESENTATION.—The
- 6 membership of each consortium shall be geographi-
- 7 cally representative and reflect the racial, ethnic,
- 8 and gender diversity of the United States.
- 9 "(b) APPLICATIONS.—Each consortium that desires
- 10 to receive a grant under this subsection shall submit an
- 11 application to the Secretary at such time, in such manner,
- 12 and containing such information and assurances as the
- 13 Secretary may require.
- 14 "(c) Report.—After the development of the vol-
- 15 untary national opportunity-to-learn standards, each con-
- 16 sortium receiving assistance under this section shall sub-
- 17 mit a report to the Secretary which discusses the back-
- 18 ground, important issues, and rationale regarding such
- 19 standards.
- 20 "(d) Authorization of Appropriations.—There
- 21 are authorized to be appropriated \$2,000,000 for fiscal
- 22 year 1998 and such sums as may be necessary for each
- 23 of the fiscal years 1999 through 2002, to carry out this
- 24 section.".

5	(2) by inserting after paragraph (6) the follow-
6	ing:
7	"(7) the term 'opportunity-to-learn standards'
8	means the criteria for, and the basis of, assessing
9	the sufficiency or quality of the resources, practices,
10	and conditions necessary at each level of the edu-
11	cation system (schools, local educational agencies,
12	and States) to provide all students with an oppor-
13	tunity to learn the material in voluntary national
14	content standards or State content standards.".
15	(d) National Education Goals Panel.—Section
16	202(j) of the Act is amended by striking "or student per-
17	formances" and inserting ", student performance, or op-
18	portunity-to-learn".
19	(e) Duties of the Goals Panel.—Section 203 of
20	the Act is amended by striking paragraph (2) and insert-
21	ing the following:
22	"(2) report on State opportunity-to-learn stand-
23	ards and strategies and the progress of States that
24	are implementing such standards and strategies to

- 1 help all students meet State content standards and
- 2 State student performance standards.".
- 3 (f) Powers of the Goals Panel.—Section
- 4 204(a)(2) of the Act is amended by inserting "voluntary
- 5 national opportunity-to-learn standards," before "and
- 6 State assessments.".
- 7 (g) State Improvement Plans.—Section 306 of
- 8 the Act is amended—
- 9 (1) by inserting after subsection (c) the follow-
- 10 ing:
- 11 "(d) Opportunity-To-Learn Standards and
- 12 Strategies.—
- 13 "(1) IN GENERAL.—Each State improvement
- plan shall establish standards or strategies for pro-
- viding all students with an opportunity to learn.
- 16 Such standards or strategies shall include such fac-
- tors as the State deems appropriate to ensure that
- all students receive a fair opportunity to achieve the
- 19 knowledge and skills as described in State content
- standards and State student performance standards
- adopted by the State.
- 22 "(2) Implementation.—Notwithstanding any
- other provision of this Act, the implementation of
- 24 opportunity-to-learn standards or strategies shall be

1	voluntary on the part of the States, local educational
2	agencies, and schools.
3	"(3) Construction.—Nothing in this section
4	shall be construed to—
5	"(A) mandate equalized spending per pupi
6	for a State, local educational agency, or school
7	or
8	"(B) mandate national school building
9	standards for a State, local educational agency
10	or school."; and
11	(2) in subsection (e), by inserting "State oppor-
12	tunity-to-learn standards or strategies," before "and
13	State assessments.".
14	(h) State Uses of Funds.—Section 308(b)(2)(A)
15	of the Act is amended by inserting "State opportunity-
16	to-learn standards," before "and State assessments".
17	(i) Assistance to Outlying Areas and Sec-
18	RETARY OF INTERIOR.—Section 315(b) of the Act is
19	amended—
20	(1) in paragraph (1)(C) by inserting ", includ-
21	ing the requirements for timetables for opportunity-
22	to-learn standards," after "improvement plans";
23	(2) by amending paragraph (2) to read as fol-
24	lowe

- 1 "(2) Plan specifics.—The reform and im-2 provement plan shall include, in addition to the re-3 quirements described above, specific provisions for—
 - "(A) opportunity-to-learn standards pertaining to residential programs and transportation costs associated with programs located on or near reservations or serving students in off-reservation residential boarding schools;
 - "(B) review and incorporation of the National Education Goals and the voluntary national content standards, voluntary national student performance standards, and voluntary national opportunity-to-learn standards, provided that such review shall include the issues of cultural and language differences; and".
 - (3) in subsection (c)(1)(A) by inserting "and to provide a framework for the implementation of opportunity-to-learn standards or strategies" before the period.
- 20 (j) REGULATIONS.—Not later than 90 days after the 21 date of the enactment of this Act, the Secretary of Edu-22 cation shall promulgate regulations or guidelines regard-23 ing the implementation of opportunity-to-learn standards.
