Ms. Christian-Green (for herself, Mr. Miller of California, Mr. Faleomavaega, and Mr. Underwood) introduced the following bill; which was referred to the Committee on Resources

A BILL

To amend the Revised Organic Act of the Virgin Islands, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. AMENDMENT TO THE REVISED ORGANIC ACT
- 4 OF THE VIRGIN ISLANDS.
- 5 (a) Temporary Absence of Officials Clari-
- 6 FIED.—Section 14 of the Revised Organic Act of the Vir-
- 7 gin Islands (48 U.S.C. 1595) is amended by adding at
- 8 the end the following new subsection:
- 9 "(g) The laws of the Virgin Islands may define
- 10 whether an absence from the Virgin Islands of the Gov-

- 1 ernor or the Lieutenant Governor, while on official busi-
- 2 ness, is a 'temporary absence' for purposes of this sec-
- 3 tion.".
- 4 (b) Short Term Borrowing Authorization.—
- 5 Section 8(b) of the Revised Organic Act of the Virgin Is-
- 6 lands (48 U.S.C. 1574(b)) is amended by adding at the
- 7 end the following:
- 8 "(iv) The legislature of the government of the Virgin
- 9 Islands may issue notes in anticipation of the collection
- 10 of taxes and revenues for the current year, but the prin-
- 11 cipal amount of such notes may not exceed the anticipated
- 12 taxes and revenues for such year. Such notes shall mature
- 13 and be redeemed not later than 1 year from the date of
- 14 issue. No extension of such notes shall be valid and no
- 15 additional notes shall be issued under this authority until
- 16 the outstanding principal and interest on all notes issued
- 17 under this authority during preceding years has been
- 18 paid.".
- 19 SEC. 2. AMENDMENT TO P.L. 94–392.
- 20 (a) Priority of Bonds.—Section 3 of Public Law
- 21 94–392 (48 U.S.C. 1574c) is amended—
- 22 (1) by striking "priority for payment" and in-
- serting "a parity lien with every other issue of bonds
- or other obligations issued for payment"; and

- 1 (2) by striking "in the order of the date of
- 2 issue".
- 3 (b) Effective date.—The amendments made by
- 4 subsection (a) shall apply to obligations issued on or after
- 5 the date of enactment of this Act.

6 SEC. 3. VIRGIN ISLANDS DEVELOPMENT ACT.

- 7 (a) SHORT TITLE.—This section may be cited as the
- 8 "Virgin Islands Development Act of 1997".
- 9 (b) Establishment of Commission.—There is es-
- 10 tablished a commission to be known as the "Commission
- 11 on the Economic Future of the Virgin Islands" (in this
- 12 Act referred to as the "Commission").
- 13 (c) Appointed Members.—(1) The Commission
- 14 shall consist of 6 members who shall be appointed by the
- 15 President.
- 16 (2) The members appointed pursuant to paragraph
- 17 (1) shall have a background and experience which shall
- 18 enable them to contribute to achievement of the purposes
- 19 of the Commission.
- 20 (3) 3 of the members appointed pursuant to para-
- 21 graph (1) shall be selected from nominations made by the
- 22 Governor of the Virgin Islands.
- 23 (d) Ex-Officio Member.—The Secretary of the In-
- 24 terior shall be an ex-officio member of the Commission.

1	(e) Chairperson.—The President shall designate 1
2	member from among the members appointed pursuant to
3	subsection (c)(1) the Chairperson of the Committee. Sub-
4	ject to general policies of the Commission, the Chairperson
5	shall be the chief executive officer of the Commission and
6	shall exercise the executive and administrative powers of
7	the Commission. The Chairperson may delegate the per-
8	formance of such executive and administrative functions
9	to the staff of the Commission.
10	(f) Vacancy.—Any vacancy in the Commission shall
11	be filled in the same manner as the original appointment
12	was made.
13	(g) Compensation.—Members of the Commission
14	shall serve without compensation, but shall be reimbursed
15	for travel, subsistence, and other necessary expenses in-
16	curred by them in the performance of their duties.
17	(h) Powers.—The Commission may—
18	(1) hold hearings, sit and act at such times and
19	places, take such testimony, and receive evidence as
20	the Committee considers appropriate;
21	(2) use the United States mail in the same
22	manner and under the same conditions as depart-
23	ments and agencies of the United States; and

1	(3) with available funds, incur such expenses
2	and enter into contracts or agreements to carry out
3	the duties of the Commission.
4	(i) Administrative Support Services.—Upon the
5	request of the Commission, the Administrator of General
6	Services shall provide to the Commission, on a reimburs-
7	able basis, office space, furnishings, equipment, staff, and
8	other administrative services.
9	(j) Assistance of Federal Agencies and De-
10	PARTMENTS.—Upon request of the Commission, the
11	President may direct the head of any Federal agency or
12	department to assist the Commission and if so directed
13	such head shall—
14	(1) furnish, upon request of the Commission,
15	information—
16	(A) that may be necessary for carrying out
17	the functions of the Commission;
18	(B) to the extent permitted by law;
19	(C) within available appropriations; and
20	(D) that is available to or procurable by
21	such department or agency; and
22	(2) detail to temporary duty with the Commis-
23	sion, on a reimbursable basis, such personnel as the
24	Commission may need to carry out its duties. Each

- such detail shall be without loss of seniority, pay, or
 other employee status.
 (k) Duties.—(1) The Commission shall make rec-
- 4 ommendations to the President and Congress on the poli-
- 5 cies and actions necessary to provide for a secure and self-
- 6 sustaining future for the local economy of the Virgin Is-
- 7 lands through 2020 and on the role of the Federal Govern-
- 8 ment.
- 9 (2) In developing recommendations pursuant to para-10 graph (1), the Commission shall—
- 11 (A) solicit and analyze information on projected 12 private sector development and shifting tourism 13 trends based on alternative forecasts of economic, 14 political, and social conditions in the Caribbean, in-15 cluding the possible effect of expansion in the near 16 future of Cuba in trade, tourism, and development;
 - (B) analyze capital infrastructure, education, social, health, and environmental needs in light of the forecasts described in subparagraph (A);
 - (C) analyze of the capability of the Virgin Islands to meet needs which are projected based on the analysis pursuant to subparagraphs (A) and (B);

- 1 (D) assemble relevant demographic, economic,
- 2 and revenue and expenditure data for the years
- 3 1972 through 1997.
- 4 (3) The Commission shall transmit a report which in-
- 5 cludes its recommendations made pursuant to this section
- 6 to the President, the Committee on Energy and Natural
- 7 Resources of the Senate, and the Committee on Resource
- 8 of the House of Representatives no later than June 30,
- 9 1999. The report shall set forth the basis for the rec-
- 10 ommendations and include the analysis made pursuant to
- 11 paragraph (2)(C).
- 12 (l) Funding.—There is hereby authorized to be ap-
- 13 propriated to the Secretary of the Interior \$300,000 per
- 14 year, in fiscal years 1998 and 1999 for the work of the
- 15 Commission.
- 16 (m) TERMINATION.—The Commission shall termi-
- 17 nate 3 months after the report is transmitted pursuant
- 18 to section (3)(k)(3).
