Ms. HARMAN (for herself, Mr. GILMAN, Mr. SOLOMON, Mr. HOLDEN, Mr. HORN, Mr. KING, Mr. McNULTY, and Mr. RAMSTAD) introduced the following bill; which was referred to the Committee on Government Reform and Oversight

A BILL

To mandate the display of the POW/MIA flag on various
occasions and in various locations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 The Congress finds that—

5 (1) the United States has fought in many wars,
6 and thousands of Americans who served in those
7 wars were captured by the enemy or listed as miss-
8 ing in action;

1 (2) many of these Americans are still missing
2 and unaccounted for, and the uncertainty surround-
3 ing their fates has caused their families to suffer
4 tragic and continuing hardships;

5 (3) as a symbol of the Nation's concern and
6 commitment to accounting as fully as possible for all
7 Americans still prisoner, missing, or unaccounted
8 for, Congress has officially recognized the National
9 League of Families POW/MIA flag and seeks fur-
10 ther to honor those Americans who in future wars
11 may be captured, or listed as missing or unac-
12 counted for; and

13 (4) the American people observe and honor with
14 appropriate ceremony and activity the third Friday
15 of September each year as National POW/MIA Rec-
16 ognition Day.

17 **SEC. 2. DISPLAY.**

18 The POW/MIA flag shall be displayed on Armed
19 Forces Day, Memorial Day, Flag Day, Independence Day,
20 Veterans Day, National POW/MIA Recognition Day, and
21 on the last business day before each of the preceding holi-
22 days, on the grounds or in the public lobbies of—

23 (1) major military installations as designated by
24 the Secretary of Defense;

25 (2) Federal national cemeteries;

- 1 (3) the national Korean War Veterans Memo-
2 rial;
3 (4) the national Vietnam Veterans Memorial;
4 (5) the White House;
5 (6) the official office of the—
6 (A) Secretary of State;
7 (B) Secretary of Defense;
8 (C) Secretary of Veterans Affairs; and
9 (D) Director of the Selective Service Sys-
10 tem; and
11 (7) United States Postal Service post offices.

12 **SEC. 3. REPEAL.**

13 Public Law 102–190 (36 U.S.C. 189 note), relating
14 to display of the POW/MIA flag, is repealed.

15 **SEC. 4. REGULATIONS AND DEFINITION.**

16 (a) REGULATIONS.—Within 180 days after the date
17 of enactment of this Act, the agencies or departments re-
18 sponsible for the locations listed in section 2 shall pre-
19 scribe such regulations as necessary to carry out the provi-
20 sions of this Act.

21 (b) DEFINITION.—As used in this section, the term
22 “POW/MIA flag” means the National League of Families
23 POW/MIA flag recognized officially and designated by sec-
24 tion 2 of Public Law 101–355.
