For the relief of Global Exploration and Development Corporation, Kerr-McGee Corporation, and Kerr-McGee Chemical Corporation.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SATISFACTION OF CLAIMS AGAINST THE**
4 **UNITED STATES.**

5 (a) PAYMENT OF CLAIMS.—The Secretary of the
6 Treasury shall pay, out of money not otherwise appro-
7 priated—



1 (1) to the Global Exploration and Development
2 Corporation, a Florida corporation incorporated in
3 Delaware, \$9,500,000;

4 (2) to Kerr-McGee Corporation, an Oklahoma
5 corporation incorporated in Delaware, \$10,000,000;
6 and

7 (3) to Kerr-McGee Chemical Corporation, an
8 Oklahoma corporation incorporated in Delaware, \$0.

9 (b) CONDITION OF PAYMENT.—(1) The payment au-
10 thorized by subsection (a)(1) is in settlement and com-
11 promise of all claims of Global Exploration and Develop-
12 ment Corporation, as described in the recommendations
13 of the Court of Federal Claims set forth in 36 Fed. Cl.
14 776.

15 (2) The payment authorized by subsections (a)(2)
16 and (a)(3) are in settlement and compromise of all claims
17 of Kerr-McGee Corporation and Kerr-McGee Chemical
18 Corporation, as described in the recommendations of the
19 Court of Federal Claims set forth in 36 Fed. Cl. 776.

20 **SEC. 2. LIMITATION ON FEES.**

21 ~~No more than 15 percent of the sums authorized to~~
22 ~~be paid by section 1 shall be paid to or received by any~~
23 ~~agent or attorney for services rendered in connection with~~
24 ~~the recovery of such sums. Any person violating this sec-~~
25 ~~tion shall be fined not more than \$1,000.~~

1 **SEC. 2. CRIMINAL PROHIBITION ON THE DISTRIBUTION OF**
 2 **CERTAIN INFORMATION RELATING TO EXPLO-**
 3 **SIVES, DESTRUCTIVE DEVICES, AND WEAP-**
 4 **ONS OF MASS DESTRUCTION.**

5 (a) *UNLAWFUL CONDUCT.*—Section 842 of title 18,
 6 *United States Code*, is amended by adding at the end the
 7 *following*:

8 “(p) *DISTRIBUTION OF INFORMATION RELATING TO*
 9 *EXPLOSIVES, DESTRUCTIVE DEVICES, AND WEAPONS OF*
 10 *MASS DESTRUCTION.*—

11 “(1) *DEFINITIONS.*—*In this subsection—*

12 “(A) *the term ‘destructive device’ has the*
 13 *same meaning as in section 921(a)(4);*

14 “(B) *the term ‘explosive’ has the same*
 15 *meaning as in section 844(j); and*

16 “(C) *the term ‘weapon of mass destruction’*
 17 *has the same meaning as in section 2332a(c)(2).*

18 “(2) *PROHIBITION.*—*It shall be unlawful for any*
 19 *person—*

20 “(A) *to teach or demonstrate the making or*
 21 *use of an explosive, a destructive device, or a*
 22 *weapon of mass destruction, or to distribute by*
 23 *any means information pertaining to, in whole*
 24 *or in part, the manufacture or use of an explo-*
 25 *sive, destructive device, or weapon of mass de-*
 26 *struction, with the intent that the teaching, dem-*

1 *onstration, or information be used for, or in fur-*
2 *therance of, an activity that constitutes a Fed-*
3 *eral crime of violence; or*

4 *“(B) to teach or demonstrate to any person*
5 *the making or use of an explosive, a destructive*
6 *device, or a weapon of mass destruction, or to*
7 *distribute to any person, by any means, infor-*
8 *mation pertaining to, in whole or in part, the*
9 *manufacture or use of an explosive, destructive*
10 *device, or weapon of mass destruction, knowing*
11 *that such person intends to use the teaching,*
12 *demonstration, or information for, or in further-*
13 *ance of, an activity that constitutes a Federal*
14 *crime of violence.”.*

15 *(b) PENALTIES.—Section 844 of title 18, United States*
16 *Code, is amended—*

17 *(1) in subsection (a), by striking “person who*
18 *violates any of subsections” and inserting the follow-*
19 *ing: “person who—*

20 *“(1) violates any of subsections”;*

21 *(2) by striking the period at the end and insert-*
22 *ing “; and”; and*

23 *(3) by adding at the end the following:*

1 “(2) violates subsection (p)(2) of section 842,
2 shall be fined under this title, imprisoned not more
3 than 20 years, or both.”; and
4 (4) in subsection (j), by striking “and (i)” and
5 inserting “(i), and (p)”.
