A BILL

To prescribe alternative payment mechanisms for the payment of annual enrollment fees for the TRICARE program of the military health care system.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PAYMENT MECHANISMS FOR TRICARE EN-
- 4 ROLLMENT FEES.
- 5 (a) Monthly Payment Option.—The Secretary of
- 6 Defense shall permit persons who enroll in the managed
- 7 health care program of the uniformed services known as

- 1 the TRICARE program to pay their annual enrollment
- 2 fees on a monthly basis.
- 3 (b) Alternative Payment Mechanisms.—In addi-
- 4 tion to existing methods by which an enrollee in the
- 5 TRICARE program may pay enrollment fees, the Sec-
- 6 retary of Defense shall establish mechanisms to provide
- 7 for payment of enrollment fees using—
- 8 (1) a deduction from military retired or retainer
- 9 pay (or equivalent pay), in the case of a member or
- former member of the uniformed services entitled to
- such pay who is an enrollee;
- 12 (2) a deduction from monthly benefits under
- section 202 or 223 of the Social Security Act (42)
- 14 U.S.C. 402, 423), in the case of a person entitled to
- such benefits who is an enrollee; and
- 16 (3) an electronic funds transfer from a checking
- or savings account designated by the enrollee.
- 18 (c) Coordination of Deduction With Other
- 19 Agencies.—The Secretary of Defense shall enter into an
- 20 agreement with the Commissioner of Social Security and
- 21 the Secretary of the Treasury to conduct the deduction
- 22 mechanism authorized by subsection (b)(2) in the same
- 23 manner as provided in section 1840(a) of the Social Secu-
- 24 rity Act (42 U.S.C. 1395s(a)) for the monthly deduction
- 25 of premiums for the medicare program.

- 1 (d) TRICARE PROGRAM DEFINED.—For purposes
- 2 of this section, the term "TRICARE program" means the
- 3 managed health care program that is established by the
- 4 Secretary of Defense under the authority of chapter 55
- 5 of title 10, United States Code, principally section 1097
- 6 of such title, and includes the competitive selection of con-
- 7 tractors to financially underwrite the delivery of health
- 8 care services under the Civilian Health and Medical Pro-
- 9 gram of the Uniformed Services.
