A BILL

To establish procedures to provide for a deficit reduction lock-box and related downward adjustment of discretionary spending limits.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Deficit Reduction
- 3 Lock-box Act of 1997".
- 4 SEC. 2. DEFICIT REDUCTION LOCK-BOX LEDGER.
- 5 (a) Establishment of Ledger.—Title III of the
- 6 Congressional Budget Act of 1974 is amended by adding
- 7 at the end the following new section:
- 8 "DEFICIT REDUCTION LOCK-BOX LEDGER
- 9 "Sec. 314. (a) Establishment of Ledger.—The
- 10 Director of the Congressional Budget Office (hereinafter
- 11 in this section referred to as the "Director") shall main-
- 12 tain a ledger to be known as the "Deficit Reduction Lock-
- 13 box Ledger". The Ledger shall be divided into entries cor-
- 14 responding to the subcommittees of the Committees on
- 15 Appropriations. Each entry shall consist of three parts:
- 16 the 'House Lock-box Balance'; the 'Senate Lock-box Bal-
- 17 ance'; and the 'Joint House-Senate Lock-box Balance'.
- 18 "(b) Components of Ledger.—Each component in
- 19 an entry shall consist only of amounts credited to it under
- 20 subsection (c). No entry of a negative amount shall be
- 21 made.
- 22 "(c) Credit of Amounts to Ledger.—(1) The Di-
- 23 rector shall, upon the engrossment of any appropriation
- 24 bill by the House of Representatives and upon the engross-
- 25 ment of that bill by the Senate, credit to the applicable

- 1 entry balance of that House amounts of new budget au-
- 2 thority and outlays equal to the net amounts of reductions
- 3 in new budget authority and in outlays resulting from
- 4 amendments agreed to by that House to that bill.
- 5 "(2) The Director shall, upon the engrossment of
- 6 Senate amendments to any appropriation bill, credit to the
- 7 applicable Joint House-Senate Lock-box Balance the
- 8 amounts of new budget authority and outlays equal to—
- 9 "(A) an amount equal to one-half of the sum of
- 10 (i) the amount of new budget authority in the House
- 11 Lock-box Balance plus (ii) the amount of new budg-
- et authority in the Senate Lock-box Balance for that
- bill; and
- "(B) an amount equal to one-half of the sum
- of (i) the amount of outlays in the House Lock-box
- Balance plus (ii) the amount of outlays in the Sen-
- 17 ate Lock-box Balance for that bill.
- 18 "(3) Calculation of Lock-Box Savings in Sen-
- 19 ATE.—For purposes of calculating under this section the
- 20 net amounts of reductions in new budget authority and
- 21 in outlays resulting from amendments agreed to by the
- 22 Senate on an appropriation bill, the amendments reported
- 23 to the Senate by its Committee on Appropriations shall
- 24 be considered to be part of the original text of the bill.

- 1 "(d) Definition.—As used in this section, the term
- 2 'appropriation bill' means any general or special appro-
- 3 priation bill, and any bill or joint resolution making sup-
- 4 plemental, deficiency, or continuing appropriations
- 5 through the end of a fiscal year.".
- 6 (b) Conforming Amendment.—The table of con-
- 7 tents set forth in section 1(b) of the Congressional Budget
- 8 and Impoundment Control Act of 1974 is amended by in-
- 9 serting after the item relating to section 313 the following
- 10 new item:

"Sec. 314. Deficit reduction lock-box ledger.".

11 SEC. 3. TALLY DURING HOUSE CONSIDERATION.

- There shall be available to Members in the House of
- 13 Representatives during consideration of any appropria-
- 14 tions bill by the House a running tally of the amendments
- 15 adopted reflecting increases and decreases of budget au-
- 16 thority in the bill as reported.

17 SEC. 4. DOWNWARD ADJUSTMENT OF 602(a) ALLOCATIONS

- 18 AND SECTION 602(b) SUBALLOCATIONS.
- 19 (a) Allocations.—Section 602(a) of the Congres-
- 20 sional Budget Act of 1974 is amended by adding at the
- 21 end the following new paragraph:
- 22 "(5) Upon the engrossment of Senate amend-
- 23 ments to any appropriation bill (as defined in section
- 24 314(d)) for a fiscal year, the amounts allocated

- 1 under paragraph (1) or (2) to the Committee on Ap-
- 2 propriations of each House upon the adoption of the
- 3 most recent concurrent resolution on the budget for
- 4 that fiscal year shall be adjusted downward by the
- 5 amounts credited to the applicable Joint House-Sen-
- 6 ate Lock-box Balance under section 314(c)(2). The
- 7 revised levels of budget authority and outlays shall
- 8 be submitted to each House by the chairman of the
- 9 Committee on the Budget of that House and shall
- be printed in the Congressional Record.".
- 11 (b) Suballocations.—Section 602(b)(1) of the
- 12 Congressional Budget Act of 1974 is amended by adding
- 13 at the end the following new sentence: "Whenever an ad-
- 14 justment is made under subsection (a)(5) to an allocation
- 15 under that subsection, the chairman of the Committee on
- 16 Appropriations of each House shall make downward ad-
- 17 justments in the most recent suballocations of new budget
- 18 authority and outlays under subparagraph (A) to the ap-
- 19 propriate subcommittees of that committee in the total
- 20 amounts of those adjustments under section 314(c)(2).
- 21 The revised suballocations shall be submitted to each
- 22 House by the chairman of the Committee on Appropria-
- 23 tions of that House and shall be printed in the Congres-
- 24 sional Record.".

1 SEC. 5. PERIODIC REPORTING OF LEDGER STATEMENTS.

- 2 Section 308(b)(1) of the Congressional Budget Act
- 3 of 1974 is amended by adding at the end the following
- 4 new sentence: "Such reports shall also include an up-to-
- 5 date tabulation of the amounts contained in the ledger and
- 6 each entry established by section 314(a).".

7 SEC. 6. DOWNWARD ADJUSTMENT OF DISCRETIONARY

- 8 SPENDING LIMITS.
- 9 The discretionary spending limits for new budget au-
- 10 thority and outlays for any fiscal year set forth in section
- 11 601(a)(2) of the Congressional Budget Act of 1974, as
- 12 adjusted in strict conformance with section 251 of the Bal-
- 13 anced Budget and Emergency Deficit Control Act of 1985,
- 14 shall be reduced by the amounts set forth in the final regu-
- 15 lar appropriation bill for that fiscal year or joint resolution
- 16 making continuing appropriations through the end of that
- 17 fiscal year. Those amounts shall be the sums of the Joint
- 18 House-Senate Lock-box Balances for that fiscal year, as
- 19 calculated under section 602(a)(5) of the Congressional
- 20 Budget Act of 1974. That bill or joint resolution shall con-
- 21 tain the following statement of law: "As required by sec-
- 22 tion 6 of the Deficit Reduction Lock-box Act of 1997, for
- 23 fiscal year [insert appropriate fiscal year] and each out-
- 24 year, the adjusted discretionary spending limit for new
- 25 budget authority shall be reduced by \$ [insert appropriate
- 26 amount of reduction] and the adjusted discretionary limit

- 1 for outlays shall be reduced by \$ [insert appropriate
- 2 amount of reduction] for the budget year and each out-
- 3 year." Notwithstanding section 904(c) of the Congres-
- 4 sional Budget Act of 1974, section 306 of that Act as it
- 5 applies to this statement shall be waived. This adjustment
- 6 shall be reflected in reports under sections 254(g) and
- 7 254(h) of the Balanced Budget and Emergency Deficit
- 8 Control Act of 1985.

9 SEC. 7. EFFECTIVE DATE.

- 10 (a) IN GENERAL.—This Act shall apply to all appro-
- 11 priation bills making appropriations for fiscal year 1998
- 12 or any subsequent fiscal year.
- 13 (b) Definition.—As used in this section, the term
- 14 "appropriation bill" means any general or special appro-
- 15 priation bill, and any bill or joint resolution making sup-
- 16 plemental, deficiency, or continuing appropriations
- 17 through the end of a fiscal year.
