A BILL

To prevent handgun violence and illegal commerce in handguns.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Twelve is Enough
- 5 Anti-Gunrunning Act".
- 6 SEC. 2. PROHIBITION AGAINST MULTIPLE HANDGUN SALES
- 7 OR PURCHASES.
- 8 (a) Prohibition.—Section 922 of title 18, United
- 9 States Code is amended by adding at the end the follow-
- 10 ing:
- 11 "(y)(1) It shall be unlawful for any licensed dealer—

- 1 "(A) during any 30-day period, to sell 2 or
- 2 more handguns to an individual who is not licensed
- 3 under section 923; or
- 4 "(B) to sell a handgun to an individual who is
- 5 not licensed under section 923 and who purchased a
- 6 handgun during the 30-day period ending on the
- date of the sale.
- 8 "(2) It shall be unlawful for any individual who is
- 9 not licensed under section 923 to purchase 2 or more
- 10 handguns during any 30-day period.
- 11 "(3) Paragraph (1) shall not apply to an exchange
- 12 of 1 handgun for 1 handgun.".
- 13 (b) Penalties.—Section 924(a)(2) of such title is
- 14 amended by striking "or (o)" and inserting "(o), or (y)".
- 15 SEC. 3. INCREASED PENALTIES FOR MAKING KNOWINGLY
- 16 FALSE STATEMENTS IN CONNECTION WITH
- 17 FIREARMS.
- 18 Section 924(a)(3) of title 18, United States Code, is
- 19 amended by striking "one year" and inserting "5 years".
- 20 SEC. 4. DEADLINES FOR DESTRUCTION OF RECORDS RE-
- 21 LATED TO CERTAIN FIREARMS TRANSFERS.
- 22 (a) Handgun Transfers Subject to the Wait-
- 23 ING PERIOD.—Section 922(s)(6)(B)(i) of title 18, United
- 24 States Code, is amended by striking "20 business days"
- 25 and inserting "35 calendar days".

- 1 (b) Firearms Transfers Subject to Instant
- 2 CHECK.—Section 922(t)(2)(C) of such title is amended by
- 3 inserting "within 35 calendar days after the date the sys-
- 4 tem provides the licensee with the number,".

5 SEC. 5. REVISED DEFINITION.

- 6 Section 921(a)(21)(C) of title 18, United States
- 7 Code, is amended by inserting ", except that such term
- 8 shall include any person who transfers more than 1 hand-
- 9 gun in any 30-day period to a person who is not a licensed
- 10 dealer" before the semicolon.
