A BILL

To terminate the effectiveness of certain amendments to the foreign repair station rules of the Federal Aviation Administration, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Aircraft Repair Station
- 5 Safety Act of 1997".

1 SEC. 2. TERMINATION OF CERTAIN FOREIGN REPAIR STA-

- 2 TION RULES.
- 3 The amendments published by the Federal Aviation
- 4 Administration on November 22, 1988 (43 Fed. Reg.
- 5 47375–47376), to parts 135 and 145 of title 14, Code
- 6 of Federal Regulations, shall not be effective after the date
- 7 of the enactment of this Act.

8 SEC. 3. APPLICABILITY OF CERTAIN REGULATIONS.

- 9 All standards set forth in regulations issued before,
- 10 on, or after the date of the enactment of this Act by the
- 11 Federal Aviation Administration that apply to a domestic
- 12 repair station or shop described in section 44707(a)(2) of
- 13 title 49, United States Code, and the personnel employed
- 14 by the domestic repair station or shop shall apply to a
- 15 foreign repair station or shop described in such section
- 16 and the personnel employed by the foreign repair station
- 17 or shop in the same manner and to the same extent as
- 18 such standards apply to the domestic repair station or
- 19 shop and the personnel employed by the domestic repair
- 20 station or shop.
- 21 SEC. 4. REVOCATION OF REPAIR STATION CERTIFICATES
- FOR USE OF UNCERTIFIED OR SUBSTANDARD
- PARTS.
- Section 44707 of title 49, United States Code, is
- 25 amended—

1	(1) by inserting "(a) In General.—" before
2	"The Administrator"; and
3	(2) by adding at the end the following:
4	"(b) REVOCATION OF REPAIR STATION CERTIFI-
5	CATES FOR USE OF UNCERTIFIED OR SUBSTANDARD
6	Parts.—The Administrator shall issue an order revoking
7	a certificate issued under section 44703 to a repair station
8	or shop described in subsection (a)(2) if the Administrator
9	finds that the station or shop knowingly used an
10	uncertified or substandard airframe, engine, propeller, ap-
11	pliance, or any other part in the repair or overhaul of an
12	aircraft."
