AN ACT

To authorize appropriations for fiscal years 1998 and 1999 for the Customs Service, the Office of the United States Trade Representative, and the International Trade Commission.

1	SECTION 1. CUSTOMS AND TRADE AGENCY AUTHORIZA-
2	TIONS FOR FISCAL YEARS 1998 AND 1999.

 There are authorized to be appropriated for the operation (including salaries and expenses) and maintenance of the air and marine interdiction programs of the Customs Service not to exceed the following:

 "(A) \$95,258,000 for fiscal year 1998.
