A BILL

To establish a Chesapeake Bay Gateways and Watertrails Network, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Chesapeake Bay Gate-
- 5 ways and Watertrails Act of 1997".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) Chesapeake bay gateways sites.—The
- 9 term "Chesapeake Bay Gateways sites" means the

8	5(a)(5).
9	(3) Chesapeake bay watershed.—The term
10	"Chesapeake Bay Watershed" shall have the mean-
11	ing determined by the Secretary.
12	(4) Chesapeake bay watertrails.—The
13	term "Chesapeake Bay Watertrails" means the
14	Chesapeake Bay Watertrails established under sec-
15	tion $5(a)(4)$.
16	(5) Secretary.—The term "Secretary" means
17	the Secretary of the Interior (acting through the Di-
18	rector of the National Park Service).
19	SEC. 3. FINDINGS.
20	Congress finds that—
21	(1) the Chesapeake Bay is a national treasure
22	and a resource of international significance;
23	(2) the region within the Chesapeake Bay wa-
24	tershed possesses outstanding natural, cultural, his-
25	torical, and recreational resources that combine to

1	form nationally distinctive and linked waterway and
2	terrestrial landscapes;
3	(3) there is a need to study and interpret the
4	connection between the unique cultural heritage of
5	human settlements throughout the Chesapeake Bay
6	Watershed and the waterways and other natural re-
7	sources that led to the settlements and on which the
8	settlements depend; and
9	(4) as a formal partner in the Chesapeake Bay
10	Program, the Secretary has an important respon-
11	sibility—
12	(A) to further assist regional, State, and
13	local partners in efforts to increase public
14	awareness of and access to the Chesapeake
15	Bay;
16	(B) to help communities and private land-
17	owners conserve important regional resources;
18	and
19	(C) to study, interpret, and link the re-
20	gional resources with each other and with
21	Chesapeake Bay Watershed conservation, res-
22	toration, and education efforts.
23	SEC. 4. PURPOSES.
24	The purposes of this Act are—

1	(1) to identify opportunities for increased public
2	access to and education about the Chesapeake Bay;
3	(2) to provide financial and technical assistance
4	to communities for conserving important natural,
5	cultural, historical, and recreational resources within
6	the Chesapeake Bay Watershed; and
7	(3) to link appropriate national parks, water-
8	ways, monuments, parkways, wildlife refuges, other
9	national historic sites, and regional or local heritage
10	areas into a network of Chesapeake Bay Gateways
11	sites and Chesapeake Bay Watertrails.

19	SEC. 6. CHESAPEAKE BAY GATEWAYS GRANTS ASSISTANCE
20	PROGRAM.
21	(a) In General.—The Secretary shall establish a
22	Chesapeake Bay Gateways Grants Assistance Program to
23	aid State and local governments, local communities, non-
24	profit organizations, and the private sector in conserving,
25	restoring, and interpreting important historic, cultural,

- 3 (b) Criteria.—The Secretary shall develop appro-
- 4 priate eligibility, prioritization, and review criteria for
- 5 grants under this section.
- 6 (c) Matching Funds and Administrative Ex-
- 7 PENSES.—A grant under this section—
- 8 (1) shall not exceed 50 percent of eligible
- 9 project costs;
- 10 (2) shall be made on the condition that non-
- 11 Federal sources, including in-kind contributions of
- services or materials, provide the remainder of eligi-
- ble project costs; and
- 14 (3) shall be made on the condition that not
- more than 10 percent of all eligible project costs be
- 16 used for administrative expenses.
- 17 SEC. 7. AUTHORIZATION OF APPROPRIATIONS.
- 18 There are authorized to be appropriated to carry out
- 19 this Act \$3,000,000 for each fiscal year.
