## A BILL

Making interim emergency supplemental appropriations for immediate needs for the fiscal year ending September 30, 1997, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, to pro-
- 5 vide interim emergency supplemental appropriations for
- 6 immediate needs for the fiscal year ending September 30,
- 7 1997, and for other purposes, namely:

17	to the start of fiscal year 1997, except those activities re-
18	imbursable or for which funds are made available by the

21	Provided, That, in administering these amounts, the Sec-
22	retary may waive, or specify alternative requirements for,
23	any provision of any statute or regulation that the Sec-

25	Secretary or the use by the recipient of these funds, except

- 1 for statutory requirements related to civil rights, fair
- 2 housing and non-discrimination, the environment, and
- 3 labor standards, upon a finding that such waiver is re-
- 4 quired to facilitate the use of such funds, and would not
- 5 be inconsistent with the overall purpose of the statute:
- 6 Provided further, That the Secretary of Housing and
- 7 Urban Development shall publish a notice in the Federal
- 8 Register governing the use of community development
- 9 block grants funds in conjunction with any program ad-
- 10 ministered by the Director of the Federal Emergency
- 11 Management Agency for buyouts for structures in disaster
- 12 areas: Provided further, That for any funds under this
- 13 head used for buyouts in conjunction with any program
- 14 administered by the Director of the Federal Emergency
- 15 Management Agency, each State or unit of general local
- 16 government requesting funds from the Secretary of Hous-
- 17 ing and Urban Development for buyouts shall submit a
- 18 plan to the Secretary which must be approved by the Sec-

19	None of the funds appropriated or otherwise made

22	enhancement program if the aggregate amount of funds
23	and/or commodities under such program exceeds
24	\$10,000,000.

6	Of the amounts recaptured under this heading during
7	fiscal year 1997 and prior years, with the exception of the
8	recaptures specified in section 214 of Public Law 104–
9	204, \$441,000,000 are rescinded: Provided, That of this
10	amount, the Secretary of Housing and Urban Develop-
11	ment shall recapture \$191,000,000 in amounts heretofore
12	made available to housing agencies for tenant-based as-
13	sistance under the Section 8 existing housing certificate
14	and housing voucher programs (42 U.S.C. 1437f and
15	1437f(o) respectively): Provided further, That the fore-
16	going recaptures shall be from amounts in the annual con-
17	tributions contract (ACC) reserve accounts established
18	and maintained by HUD.
19	TITLE III—GENERAL PROVISION, THIS ACT
20	Sec. 301. No part of any appropriation contained in
21	this Act shall remain available for obligation beyond the
22	current fiscal year unless expressly so provided herein.
23	This Act may be cited as the "Interim Emergency
24	Supplemental Appropriations Act of 1997".
