Mr. WEYGAND introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To reduce the incidence of child abuse and neglect, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. GRANT REDUCTION.

(a) GRANT REDUCTION FOR NONCOMPLIANCE.—Section 506 of title I of the Omnibus Crime Control and Safe

Streets Act of 1968 is amended by adding at the end the following:

"(g) CHILD ABUSE.—

"(1) IN GENERAL.—The funds available under

this subpart for a State shall be reduced by 10 per-

cent and redistributed under paragraph (2) unless

1	the State has in effect throughout the State a law
2	which requires, at a minimum, that—
3	"(A) a person convicted for a first offense
4	of inflicting serious bodily injury on a child
5	serves a term of imprisonment of not less than
6	10 years;
7	"(B) a person previously convicted of in-
8	flicting bodily injury or serious bodily injury on
9	a child who is convicted subsequently for inflict-
10	ing serious bodily injury on a child serves a
11	term of imprisonment of not less than 20 years;
12	"(C) a person convicted for a first offense
13	of inflicting bodily injury on a child serves a
14	term of imprisonment of not less than five
15	years; and
16	"(D) a person previously convicted of in-
17	flicting serious bodily injury or bodily injury on
18	a child who is convicted subsequently for inflict-
19	ing bodily injury on a child serves a term of im-
20	prisonment of not less than 10 years.
21	"(2) Redistribution.—To the extent made
22	available in appropriations Acts, any funds available
23	for redistribution shall be redistributed to participat-
24	ing States that have in effect a law referred to in
25	paragraph (1).

- 1 "(3) COMPLIANCE.—The Attorney General
- 2 shall issue regulations to ensure compliance with the
- 3 requirements of paragraph (1).".
- 4 (b) Conforming Amendment.—Section 506(a) of
- 5 title I of the Omnibus Crime Control and Safe Streets Act
- 6 of 1968 is amended by striking "subsection (f)," and in-
- 7 serting "subsections (f) and (g),".
- 8 (c) Effective Date.—The amendments made by
- 9 subsection (a) shall take effect on the first day of each
- 10 fiscal year succeeding the first fiscal year beginning 2
- 11 years after the date of the enactment of this Act.
