## A BILL

To amend chapter 89 of title 5, United States Code, to modify the formula under which the Government contribution for a Federal employee or annuitant enrolled in a health benefits plan under such chapter is determined.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. GOVERNMENT CONTRIBUTION.
- 4 (a) IN GENERAL.—Section 8906 of title 5, United
- 5 States Code, is amended by striking subsection (a) and

- 1 all that follows through the end of paragraph (1) of sub-
- 2 section (b) and inserting the following:
- 3 "(a)(1) The Office of Personnel Management shall,
- 4 not later than October 1 of each year, determine the
- 5 weighted average of the subscription charges that will be
- 6 in effect during the following contract year with respect
- 7 to—
- 8 "(A) enrollments under this chapter for self
- 9 alone; and
- 10 "(B) enrollments under this chapter for self
- and family.
- 12 "(2) In determining each weighted average under
- 13 paragraph (1), the weight to be given to a particular sub-
- 14 scription charge shall, with respect to each plan (and op-
- 15 tion) to which it is to apply, be commensurate with the
- 16 number of enrollees enrolled in such plan (and option) as
- 17 of March 31 of the year in which the determination is
- 18 being made.
- 19 "(3) For purposes of paragraph (2), the term 'en-
- 20 rollee' means any individual who, during the contract year
- 21 for which the weighted average is to be used under this
- 22 section, will be eligible for a Government contribution de-
- 23 termined under this section.
- 24 "(b)(1) Except as provided in paragraphs (2) and
- 25 (3), the biweekly Government contribution for health bene-

- 1 fits for an employee or annuitant enrolled in a health bene-
- 2 fits plan under this chapter is adjusted to an amount equal
- 3 to 72 percent of the weighted average under subsection
- 4 (a)(1)(A) or (B), as applicable. For an employee, the ad-
- 5 justment begins on the first day of the employee's first
- 6 pay period of each year. For an annuitant, the adjustment
- 7 begins on the first day of the first period of each year
- 8 for which an annuity payment is made.".
- 9 (b) Effective Date.—This section and the amend-
- 10 ment made by this section shall take effect on the first
- 11 day of the contract year that begins in 1999, except that
- 12 nothing in this subsection shall prevent the Office of Per-
- 13 sonnel Management from taking any action, before such
- 14 first day, which it considers necessary in order to ensure
- 15 the timely implementation of such amendment.
