A BILL

For the relief of certain Persian Gulf evacuees.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ADJUSTMENT OF STATUS FOR CERTAIN PER-**
4 **SIAN GULF EVACUEES.**

5 (a) IN GENERAL.—The Attorney General shall adjust
6 the status of each alien referred to in subsection (b) to
7 that of an alien lawfully admitted for permanent residence
8 if the alien—

9 (1) applies for such adjustment;

10 (2) has been physically present in the United
11 States for at least 1 year and is physically present

1 in the United States on the date the application for
2 such adjustment is filed;

3 (3) is admissible to the United States as an im-
4 migrant, except as provided in subsection (c); and

5 (4) pays a fee (determined by the Attorney
6 General) for the processing of such application.

7 (b) ALIENS ELIGIBLE FOR ADJUSTMENT OF STA-
8 TUS.—The benefits provided in subsection (a) shall apply
9 to the following aliens:

10 (c) WAIVER OF CERTAIN GROUNDS FOR INADMIS-
11 SIBILITY.—The provisions of subsection (e) and para-
12 graphs (4), (5), and (7)(A) of subsection (a) of section
13 212 of the Immigration and Nationality Act shall not
14 apply to adjustment of status under this Act and the At-
15 torney General may waive any other provision of section
16 212 of the Immigration and Nationality Act (other than
17 paragraph (2)(C) and subparagraphs (A), (B), (C), or (E)
18 of paragraph (3)) with respect to such an adjustment for
19 humanitarian purposes, to assure family unity, or when
20 it is otherwise in the public interest.

21 (d) DATE OF APPROVAL.—Upon the approval of an
22 application for adjustment of status under this section, the
23 Attorney General shall create a record of the alien’s ad-
24 mission as an alien lawfully admitted for permanent resi-

1 dence as of the date of the alien's parole or other admis-
2 sion into the United States.

3 (e) OFFSET IN NUMBER OF VISAS AVAILABLE.—

4 Upon each granting to an alien of the status of having
5 been lawfully admitted for permanent residence under this
6 section, the Secretary of State shall instruct the proper
7 officer to reduce by 1, during the current or next following
8 fiscal year, the total number of immigrant visas that are
9 made available to natives of the country of the alien's birth
10 under section 203(a) of the Immigration and Nationality
11 Act or, if applicable, the total number of immigrant visas
12 that are made available to natives of the country of the
13 alien's birth under section 202(e) of such Act.

14 (f) TEMPORARY STAY OF REMOVAL AND WORK AU-
15 THORIZATION.—The Attorney General—

16 (1) shall refrain from deporting or removing
17 from the United States an alien who is eligible for
18 adjustment of status under this section, but who is
19 not yet lawfully admitted for permanent residence;
20 and

21 (2) shall authorize such an alien to engage in
22 employment in the United States.
