## A BILL

To provide for an enumeration of family caregivers as part  
of the 2000 decennial census of population.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Family Caregiver Enu-  
5       meration Act”.

6       **SEC. 2. ENUMERATION OF FAMILY CAREGIVERS.**

7       (a) IN GENERAL.—The Secretary of Commerce shall  
8       take appropriate measures to ensure that an enumeration

1 of family caregivers shall be taken as part of the 2000  
2 decennial census of population.

3 (b) DEFINITIONS.—For purposes of this section:

4 (1) FAMILY CAREGIVER.—The term “family  
5 caregiver” means a caregiver who is the spouse of  
6 the care recipient or whose relationship to the care  
7 recipient is as described in any of paragraphs (1)  
8 through (9) of section 152(a) of the Internal Reve-  
9 nue Code of 1986 (applied, for purposes of this  
10 paragraph, by substituting “care recipient” for “tax-  
11 payer” each place it appears).

12 (2) CAREGIVER.—The term “caregiver” means  
13 an individual who, without financial compensation,  
14 regularly assists a care recipient in carrying out 1  
15 or more activities or instrumental activities of daily  
16 living.

17 (3) CARE RECIPIENT.—The term “care recipi-  
18 ent” means an individual (of any age) who requires  
19 substantial assistance from another individual in  
20 carrying out 1 or more activities or instrumental ac-  
21 tivities of daily living due to a physical or mental  
22 condition or impairment which has lasted or is ex-  
23 pected to last longer than 3 months, or a terminal  
24 condition.

1           (4) ACTIVITY OF DAILY LIVING.—The term “ac-  
2       tivity of daily living” includes breathing, bathing,  
3       dressing, eating, transferring, and toileting.

4           (5) INSTRUMENTAL ACTIVITY OF DAILY LIV-  
5       ING.—The term “instrumental activity of daily liv-  
6       ing” means shopping for personal items, obtaining  
7       and taking medication, managing money, preparing  
8       meals, using the telephone, performing housework,  
9       and any other measure of living independently or  
10      functioning at a level commensurate with one’s age.

11          (6) CENSUS OF POPULATION.—The term “cen-  
12      sus of population” has the meaning given such term  
13      by section 141(g) of title 13, United States Code.
