A BILL

To provide for an annual report to Congress on the intelligence activities of the People's Republic of China directed against or affecting the interests of the United States.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. REPORT ON INTELLIGENCE ACTIVITIES OF THE
- 4 PEOPLE'S REPUBLIC OF CHINA.
- 5 (a) Report to Congress.—The Director of Central
- 6 Intelligence and the Director of the Federal Bureau of In-
- 7 vestigation, jointly, in consultation with the heads of other

- 1 appropriate Federal agencies, including the National Se-
- 2 curity Agency, and the Departments of Defense, Justice,
- 3 Treasury, and State, shall prepare a report on intelligence
- 4 activities of the People's Republic of China directed
- 5 against or affecting the interests of the United States.
- 6 (b) CONTENTS OF REPORT.—Each report under sub-
- 7 section (a) shall include information concerning the follow-
- 8 ing:
- 9 (1) Political, military, and economic espionage.
- 10 (2) Intelligence activities designed to gain polit-
- ical influence, including activities undertaken or co-
- ordinated by the United Front Works Department of
- the Chinese Communist Party.
- 14 (3) Efforts to gain direct or indirect influence
- 15 through commercial or noncommercial
- intermediaries subject to control by the People's Re-
- public of China, including enterprises controlled by
- the People's Liberation Army.
- 19 (4) Disinformation and press manipulation by
- the People's Republic of China with respect to the
- United States, including activities undertaken or co-
- ordinated by the United Front Works Department of
- the Chinese Communist Party.
- 24 (c) Submission of Report.—Not later than March
- 25 31 of each year, the Director of Central Intelligence and

- 1 the Director of the Federal Bureau of Investigation, joint-
- 2 ly, shall submit to the Congress classified and unclassified

3 versions of the report described in subsection (a).
