A BILL

To amend the Act popularly known as the Recreation and Public Purposes Act to authorize transfers of certain public lands or national forest lands to local education agencies for use for elementary or secondary schools, including public charter schools, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Education Land Grant
5	Act''.
6	SEC. 2. TRANSFERS OF PUBLIC LANDS OR NATIONAL FOR-
7	EST LANDS FOR USE FOR ELEMENTARY AND
8	SECONDARY SCHOOLS.
9	Section 1 of the Act entitled "An Act to authorize
10	acquisition or use of public lands by States, counties, or
11	municipalities for recreational purposes", approved June
12	14, 1926 (Chapter 578; 44 Stat. 741; 43 U.S.C. 869),
13	popularly known as the Recreation and Public Purposes
14	Act, is amended—
15	(1) in subsection (a), in the first sentence—
16	(A) by inserting "or national forest lands"
17	after "public lands"; and
18	(B) by inserting "including to a local edu-
19	cation agency for use for an elementary or sec-
20	ondary school, including a public charter
21	school," after "public purposes,";
22	(2) in subsection (a), in the second sentence, by
23	striking "public lands" and inserting "lands";
24	(3) in subsection (e), by striking "in any na-
25	tional forest, national park, or national monument,

1	or national wildlife refuge," and inserting "in the
2	National Park System, the National Wildlife Refuge
3	System, the National Wilderness Preservation Sys-
4	tem, the National Wild and Scenic Rivers System,
5	the National Trails System, any Bureau of Land
6	Management area of critical environmental concern,
7	or any national recreation area," and
8	(4) by adding at the end the following:
9	"(d) Deadline for Consideration of Applica-
10	TION FOR USE FOR SCHOOL.—If the Secretary receives
11	an application from a duly qualified applicant that is a
12	local education agency seeking a conveyance of land under
13	this Act for use for an elementary or secondary school,
14	including a public charter school, the Secretary shall—
15	"(1) before the end of the 10-day period begin-
16	ning on the date of that receipt, provide notice of
17	that receipt to the applicant; and
18	"(2) before the end of the 60-day period begin-
19	ning on the date of that receipt—
20	"(A) determine whether or not to convey
21	land pursuant to the application, and notify the
22	applicant of that determination; or
23	"(B) report to the Congress and the appli-
24	cant the reasons that determination has not
25	been made."

- 3 (a) Transfers.—The Secretary of Agriculture may,
- 4 upon a finding that the transfer of certain National Forest
- 5 lands for local public school purposes would serve the public
- 6 interest, authorize the transfer of up to 40 acres of National
- 7 Forest lands to a local governmental entity for public school
- 8 purposes. The Secretary may make available only those Na-
- 9 tional Forest lands that have been identified for disposal
- 10 or exchange or are not otherwise needed for National Forest
- 11 purposes. The Secretary shall make such transfers using the
- 12 least amount of land required for the efficient operation of
- 13 the project involved.
- 14 (b) Costs.—Such transfers may be made at dis-
- 15 counted or no-cost. The Secretary shall provide for a no-
- 16 cost transfer to a local governmental entity for public school
- 17 purposes if the Secretary determines that the charges for
