## A BILL

To amend title 38, United States Code, to require that health-care professionals of the Department of Veterans Affairs be assigned to facilities of the Department only in States in which they are licensed to practice, and to require that the Secretary of Veterans Affairs follow State requirements concerning the filing of death certificates.

- 3 (a) REQUIREMENT FOR LICENSURE BY STATE IN
- 4 Which a Health-Care Professional Works.—(1)
- 5 Subchapter I of chapter 74 of title 38, United States
- 6 Code, is amended by adding at the end the following new
- 7 section:

### 8 "§ 7412. Licensure of health care professionals

- 9 "(a) The Secretary may assign a health-care profes-
- 10 sional to duties at a facility of the Department in a capac-
- 11 ity involving the professional functions of that health-care
- 12 professional only at a facility located in a State in which
- 13 that health-care professional is licensed to practice.
- 14 "(b) For purposes of this section, the term 'health-
- 15 care professional' means an employee of the Veterans
- 16 Health Administration described in section 7401(1) of this
- 17 title.".
- 18 (2) The table of sections at the beginning of such
- 19 chapter is amended by inserting after the item relating
- 20 to section 7411 the following new item:
  - "7412. Licensure of health care professionals.".
- 21 (b) Effective Date.—Section 7412 of title 38,
- 22 United States Code, as added by subsection (a), shall take
- 23 effect at the end of the six-month period beginning on the
- 24 date of the enactment of this Act.

- 2 CERNING FILING OF DEATH CERTIFICATES.
- 3 (a) In General.—Subchapter II of chapter 73 of
- 4 title 38, United States Code, is amended by adding at the

- 8 "When an individual dies in a facility of the Depart-
- 9 ment, the Secretary shall follow requirements of the State

- 13 (b) CLERICAL AMENDMENT.—The table of sections
