A BILL

9 The Congress finds and declares the following:

of 1973 (16 U.S.C. 1531 et seg.).

- 10 (1) The American public recognizes the impor-11 tance of protecting the natural environmental legacy 12 of this Nation.
 - (2) It is only through the protection of all species of plants and animals and the ecosystems upon which they depend that we will conserve a world for our children with the spiritual, medicinal, agricultural, and economic benefits that plants and animals offer. Moreover, we have a moral responsibility not to drive other species to extinction.
 - (3) We are rapidly proceeding in a manner that will deny a world of abundant, varied species to future generations.
- 23 (4) Although the Endangered Species Act of 24 1973 has prevented the extinction of many animal, 25 plant, and fish species, many of these species have

- not fully recovered and the Act must ensure their
 long-term survival and recovery.
 - (5) Federal agencies and others should act to protect declining species before they need the full application of the Endangered Species Act of 1973.
 - (6) All members of the public have a right to be involved in the decisions made to protect biodiversity.
 - (7) To avoid extinction in the wild, habitats must be conserved by using the best available science.
 - (8) Only by taking actions that implement the existing recovery goal of the Endangered Species Act of 1973 can we ensure that species will eventually be removed from the lists of endangered species and threatened species.
 - (9) We can provide assurances for communities, local governments, and private landowners that will enable them to move forward with planning and economic development efforts while still protecting species.

TITLE I—AMENDMENTS TO EN-DANGERED SPECIES ACT OF 2 1973 3 SEC. 101. DEFINITIONS. 4 5 Section 3 (16 U.S.C. 1532) is amended— 6 (1) by amending paragraph (5) to read as fol-7 lows: 8 "(5) The term 'critical habitat' for a threatened or endangered species includes— 9 "(A) the specific areas within the geographic 10 11 area occupied by the species, at the time it is listed 12 in accordance with the provisions of section 4 of this 13 Act, on which are found those physical or biological 14 features (i) essential to the conservation of the spe-15 cies, and (ii) which may require special management 16 considerations or protections; and 17 "(B) specific areas outside the geographical 18 area occupied by the species at the time it is listed 19 in accordance with the provisions of section 4 of the 20 Act, upon a determination by the Secretary that 21 such areas are essential for the conservation of the 22 species."; 23 (2) by amending paragraph (16) to read as fol-

lows:

1	"(16) The term 'species' includes any subspecies of
2	fish or wildlife or plants, any distinct population segment
3	of any species of vertebrate fish or wildlife which inter-
4	breeds when mature, and the last remaining distinct popu-
5	lation segment in the United States of any plant or inver-

7	(3) by adding at the end the following new
8	paragraphs:
9	"(22) The term 'candidate species' means any spe-
10	cies—
11	"(A) that is not the subject of a proposed rule
12	under section $4(a)(1)$;
13	"(B) that the Secretary is considering for list-
14	ing as an endangered species or threatened species;
15	and
16	"(C) for which—
17	"(i) the Secretary has sufficient informa-
18	tion to support a proposed rule for that listing;
19	or
20	"(ii) the Secretary has information indicat-
21	ing that proposing that listing may be appro-
22	priate, but for which further information is re-
23	quired to support such a proposed rule.
24	"(23)(A) The term 'cumulative impacts' means those
25	direct impacts and indirect impacts on a species or its

1	habitat that result from the incremental impact of the pro-
2	posed action when added to other past, present, and rea-
3	sonably foreseeable future actions, regardless of what per-
4	son undertakes such other actions.
5	"(B) For purposes of subparagraph (A)—
6	"(i) the term 'impacts' includes—
7	"(I) the loss of individual members of the
8	species;
9	"(II) diminishment of the species' habitat,
10	both qualitatively and quantitatively;
11	"(III) disruption of normal behavioral pat-
12	terns, including but not limited to breeding,
13	feeding, or sheltering; and
14	"(IV) impairment of the species' ability to
15	withstand random fluctuations in environmental
16	conditions;
17	"(ii) the term 'direct impacts' means impacts
18	that are caused by the proposed action and that
19	occur at the same time and place as the proposed
20	action; and
21	"(iii) the term 'indirect impacts' means impacts
22	that are caused by the proposed action and that
23	occur later in time than, or farther removed in dis-
24	tance from, the proposed action, but that are still
25	reasonably foreseeable.

- 1 "(24) The term 'jeopardize the continued existence
- 2 of means to engage in an action that reasonably would
- 3 be expected, directly, indirectly or cumulatively, to reduce
- 4 appreciably the likelihood of recovery in the wild of any
- 5 foreign or domestic species included in a list published
- 6 under section 4(c).
- 7 "(25) The term 'minimize'—
- 8 "(A) subject to subparagraph (B), means to
- 9 avoid to the extent possible, in designing and engag-
- ing in an activity, adverse impacts to a threatened
- species or endangered species in the course of the
- 12 activity; and
- "(B) for an activity for which it is determined,
- after consideration of a reasonable range of alter-
- natives, that avoidance of adverse impacts to the
- species is impossible, to design and implement the
- activity in a manner that results in the lowest pos-
- sible individual and cumulative adverse impacts on
- the species.
- 20 "(26) The term 'mitigate' means to redress adverse
- 21 impacts to a threatened species or endangered species in
- 22 connection with an action, by replacing the number of
- 23 plants and animals in the wild, and the value to the species
- 24 of the habitat, that were lost as a result of the adverse
- 25 impacts.

1	"(27) The term 'recovery' means that the threats to
2	a species, as analyzed under section 4(a), have been elimi-
3	nated, the species has achieved long-term viability, and the
4	protective measures under this Act are no longer needed.
5	"(28) The term 'interim habitat' includes the habitat
6	necessary to support either current populations of a spe-
7	cies or populations which are necessary to ensure survival,
8	whichever is larger.".
9	SEC. 102. DESIGNATION OF CRITICAL HABITAT AND SUR-
10	VIVAL HABITAT.
11	Section 4 (16 U.S.C. 1531) is amended—
12	(1) in subsection (a), by amending paragraph
13	(3) to read as follows:
14	"(3) The Secretary, by regulation promulgated in ac-
15	cordance with subsection (b)—
16	"(A) subject to subparagraph (C), shall, concur-
17	rently with making a determination under paragraph
18	(1) that a species is an endangered species or threat-
19	ened species, designate interim habitat of the spe-
20	cies;
21	"(B) subject to subparagraph (C), shall concur-
22	rently with adoption of the final recovery plan for a
23	species under subsection (f), designate critical habi-
24	tat of the species;

- "(C) in the case of a highly migratory marine species, shall designate interim habitat and critical habitat for the species to the maximum extent biologically determinable; and
- "(D) shall, from time to time thereafter as appropriate, revise such designations, if the Secretary determines that such revision would expedite or assist the recovery of the species."; and
- 9 (2) in subsection (b), by amending paragraph 10 (2) to read as follows:
- 11 "(2)(A) The Secretary shall designate critical habitat, and make revisions thereto, under subsection (a)(3) on the 12 basis of the best scientific data available and after taking into consideration the economic impact, and any other rel-14 15 evant impact, of specifying any particular area as critical habitat. Interim habitat designated at the time of listing 16 17 shall be revised and finalized as critical habitat concur-18 rently with the adoption of the final recovery plan. The 19 Secretary may exclude any area from critical habitat on the basis that the benefits of such exclusion outweigh the 20 21 benefits of specifying such area as part of the critical habi-
- tat, only if the Secretary determines, based on the bestscientific and commercial data available, that the failure
- 24 to designate such area as critical habitat will not impair
- 25 the species' recovery.

- 1 "(B) The Secretary shall designate interim habitat
- 2 of a species based only on biological factors, giving special
- 3 consideration to habitat that is currently occupied by the
- 4 species.".

5 SEC. 103. SCHEDULE FOR LISTING DETERMINATIONS.

- 6 Section 4(b)(3)(C) (16 U.S.C. 1533(b)(3)(C)) is
- 7 amended by adding at the end the following:
- 8 "(iv) The Secretary shall, by not later than 1 year
- 9 after the date of enactment of the Endangered Species Re-
- 10 covery Act of 1997, cause to be published in the Federal
- 11 Register either a proposal to list or a not warranted find-
- 12 ing under subparagraph (B)(i) for each species for which
- 13 a finding under subparagraph (B)(iii) was made before
- 14 that date of enactment.
- 15 "(v) The Secretary shall, not later than 4 years after
- 16 the date on which a finding under subparagraph (B)(iii)
- 17 is published for a species for which a finding under sub-
- 18 paragraph (B)(iii) was made after the date of enactment
- 19 of the Endangered Species Recovery Act of 1997, or a
- 20 date on which such a species is otherwise designated by
- 21 the Secretary as a candidate species, cause to be published
- 22 in the Federal Register—
- 23 "(I) a proposal to list the species under sub-
- paragraph (B)(ii); or

1	"(II) a not warranted finding under subpara-
2	graph (B)(i).".
3	SEC. 104. CONTENTS OF LISTING PETITIONS.
4	Section $4(b)(3)$ (16 U.S.C. $1533(b)(3)$) is amended
5	by adding at the end the following:
6	"(E) A petition referred to in subparagraph (A) shall,
7	to the maximum extent practicable, contain the following
8	information:
9	"(i) The current known and historic ranges of
10	the species.
11	"(ii) The most recent population estimates and
12	trends, if available.
13	"(iii) The reason that the petitioned action is
14	warranted, including known or perceived threats to
15	the species.
16	"(iv) A bibliography of scientific literature on
17	the species, if any, in support of the petition.
18	"(v) Any other information that the petitioner
19	feels is appropriate.".
20	SEC. 105. RECOVERY PLANNING.
21	Section 4(f) (16 U.S.C. 1533(f)) is amended—
22	(1) in paragraph (1)—
23	(A) in the first sentence—
24	(i) by striking "develop and imple-
25	ment plans" and inserting "within 18

1	months after the date of the adding of a
2	species to a list under subsection (c), de-
3	velop a draft plan, and within 30 months
4	after that date, develop and begin imple-
5	mentation of a final plan"; and
6	(ii) by inserting "each" before "en-
7	dangered";
8	(iii) by striking ", unless he finds that
9	such plan will not promote the conserva-
10	tion of the species"; and
11	(B) by striking subparagraph (B) and in-
12	serting the following:
13	"(B) include in each plan specific provisions, in-
14	cluding provisions required under subparagraph (C),
15	that provide for the conservation in the recovery
16	plan area of all species listed as endangered species
17	or threatened species, candidate species, and species
18	proposed for listing;
19	"(C) incorporate in each recovery plan for a
20	species—
21	"(i) a description of such site-specific man-
22	agement actions, noting those of the highest
23	priority and greatest recovery potential, as may
24	be necessary to achieve the plan's goal for the
25	recovery of the species;

1	"(ii) objective, measurable criteria, includ-
2	ing habitat needs and population levels, that,
3	when met, would result in a determination, in
4	accordance with the provisions of this section,
5	that the species be removed from the list;
6	"(iii) estimates of the time required and
7	the cost to carry out those measures needed to
8	achieve the plan's goal and to achieve inter-
9	mediate steps toward that goal;
10	"(iv) a general description of types of ac-
11	tions likely to violate the taking prohibition of
12	section 9 or the jeopardy prohibition of section
13	7; and
14	"(v) a list of Federal agencies, States,
15	tribes, and local government entities signifi-
16	cantly affected by the goals or management ac-
17	tions set forth in the recovery plan, that should
18	complete a recovery implementation plan pursu-
19	ant to paragraph (5)(A); and
20	"(D) for the purposes of determining the cri-
21	teria under subparagraph (C)(ii), select, in consulta-
22	tion with the National Academy of Sciences, inde-
23	pendent scientists who—
24	"(i) through publication of peer-reviewed
25	scientific literature, have demonstrated relevant

1	scientific expertise in that species or similar
2	species; and
3	"(ii) do not have, nor represent anyone
4	with, a significant economic interest in the re-
5	covery plan."; and
6	(2) by amending paragraph (5) to read as fol-
7	lows:
8	"(5)(A) Each Federal agency significantly affected by
9	the goals or management actions set forth in a final recov-
10	ery plan shall develop and implement a plan (in this para-
11	graph referred to as a 'recovery implementation plan'),
12	after providing public notice and an opportunity for public
13	review and comment on the recovery implementation plan.
14	"(B) Each recovery implementation plan shall—
15	"(i) identify the agency's affirmative conserva-
16	tion duties and management responsibilities which
17	will contribute to the achievement of recovery goals
18	identified in the final recovery plan;
19	"(ii) set forth specific agency actions, time-
20	tables, and funding required to achieve and monitor
21	progress of these recovery goals or management re-
22	sponsibilities; and
23	"(iii) identify any lands or waters under the
24	agency's jurisdiction or ownership that currently
25	provide or may provide suitable habitat for the spe-

- 1 cies, identify any actions needed to acquire addi-
- 2 tional suitable habitat under section 5(a), and de-
- 3 scribe management actions the agency will take on
- 4 lands or waters within its jurisdiction or ownership
- 5 to contribute toward recovery of the species.
- 6 "(C) Consistent with section 6, the Secretary shall
- 7 cooperate to the maximum extent practicable with States,
- 8 tribes, and local government entities that are significantly
- 9 affected by a final recovery plan, to develop State coopera-
- 10 tive plans to achieve the goals and implement the manage-
- 11 ment actions identified in the recovery plan.".
- 12 SEC. 106. COOPERATIVE AGREEMENTS.
- 13 Section 6 (16 U.S.C. 1535) is amended by adding
- 14 at the end of each of subsections (c) and (d) the following:
- 15 "(3) In this subsection, the term 'State' includes, in
- 16 addition to the entities described in section 3(17), any In-
- 17 dian tribe.".
- 18 SEC. 107. INTERAGENCY COOPERATION.
- 19 (a) Federal Agency Actions and Consulta-
- 20 Tions.—Section 7(a) (16 U.S.C. 1536(a)) is amended—
- 21 (1) in paragraph (1) in the second sentence—
- 22 (A) by striking "All other Federal agen-
- cies" and inserting "Each other Federal agen-
- 24 cy"; and

1	(B) by inserting before the period the fol-
2	lowing: ", including recovery actions identified
3	in recovery implementation plans of the agen-
4	ey'';
5	(2) in paragraph (2) in the first sentence by in-
6	serting after "to be critical," the following: "in such
7	a way as to diminish the value of that habitat for
8	the recovery of the species,"; and
9	(3) by adding at the end the following:
10	"(5)(A) Any Federal agency may consult with the
11	Secretary regarding any action that may affect any can-
12	didate species or species proposed for listing under section
13	4(e).
14	"(B) If consultation under this paragraph is com-
15	pleted before the listing of the species—
16	"(i) no additional consultation is required solely
17	as a consequence of the subsequent listing of that
18	species, if the Secretary determines that there have
19	been no significant changes in the agency proposal
20	and there is no significant new information that was
21	not considered in the original consultation; and
22	"(ii) the Secretary shall reinitiate consultation
23	under paragraph (2) if the Secretary determines
24	that there has been a significant change in the agen-
25	cy proposal or that there is significant new informa-

- 1 tion that was not considered in the original consulta-
- 2 tion.
- 3 "(C) A Federal agency shall notify the Secretary of
- 4 any significant change in, or significant new information
- 5 regarding, any action regarding which the agency con-
- 6 sulted with the Secretary under this paragraph.
- 7 "(6) The head of each Federal agency shall monitor
- 8 the status and trends of endangered species, threatened
- 9 species, and candidate species that occur on lands or in
- 10 waters under the administration of the agency.".
- 11 (b) Opinion of Secretary.—Section 7(b) (16
- 12 U.S.C. 1536(b)) is amended—
- 13 (1) by amending paragraph (3) to read as fol-
- 14 lows:
- 15 "(3)(A) Promptly after conclusion of consultation
- 16 under paragraph (2), (3), or (5) of subsection (a), the Sec-
- 17 retary shall provide to the Federal agency and the appli-
- 18 cant, if any, a written statement setting forth the Sec-
- 19 retary's opinion, and a summary of the information on
- 20 which the opinion is based, detailing how the agency action
- 21 affects the species or its critical habitat, including the
- 22 amount of habitat and the number of members of the spe-
- 23 cies that will be taken, and conservation actions to mini-
- 24 mize and mitigate the impacts of any incidental taking
- 25 that may result from the action. If jeopardy or adverse

- 1 modification is found, the Secretary shall suggest those
- 2 reasonable and prudent alternatives that the Secretary be-
- 3 lieves would not violate subsection (a)(2), and can be
- 4 taken by the Federal agency or applicant in implementing
- 5 the agency action.";
- 6 (2) by adding at the end the following:
- 7 "(5) The Secretary shall, upon receipt of a request
- 8 to initiate consultation under paragraph (2), (3), or (5)
- 9 of subsection (a), promptly publish a notice in the Federal
- 10 Register announcing that the consultation has been initi-
- 11 ated and briefly describing the proposed agency action.
- 12 The Secretary shall make available upon request any in-
- 13 formation in the Secretary's possession or control concern-
- 14 ing the consultation or the opinion prepared pursuant to
- 15 this subsection with respect to the consultation.
- 16 "(6)(A) The Secretary shall, in preparing an opinion
- 17 pursuant to this subsection, invite independent scientists
- 18 with expertise on species that may be affected by the pro-
- 19 posed agency action to provide input into the consultation
- 20 or opinion.
- 21 "(B) For purposes of this paragraph, an independent
- 22 scientist is an individual described in section 4(f)(1)(D).
- "(7) Not later than 30 days after the date the Sec-
- 24 retary provides a written statement under paragraph (3)
- 25 to the Federal agency and the applicant for a permit, if

1	any, the Secretary shall publish in the Federal Register
2	the Secretary's findings and reasons for making any deter-
3	mination under this subsection."; and
4	(3) in paragraph (4)—
5	(A) in subparagraph (B), by striking "will
6	not violate such subsection" and inserting "will
7	not interfere with the timely achievement of re-
8	covery goals" each time it occurs;
9	(B) in clause (ii), by inserting "and miti-
10	gate" after "minimize";
11	(C) in clause (iii), by striking "and" after
12	the comma at the end;
13	(D) in clause (iv), by striking the period at
14	the end and inserting ", and"; and
15	(E) by adding at the end the following:
16	"(v) directs the Federal agency to assess and
17	report to the Secretary two years after the date of
18	issuance of the written statement and every two
19	years thereafter for as long as any incidental take
20	continues, the amount of incidental take that has oc-
21	curred as a direct impact, indirect impact, or cumu-
22	lative impact.
23	If an assessment under clause (v) indicates that the
24	amount of incidental take authorized under the written
25	statement has been exceeded, the Federal agency shall im-

- 1 mediately reinitiate consultation with the Secretary pursu-
- 2 ant to section 7(a)(2).".
- 3 (c) BIOLOGICAL ASSESSMENT.—Section 7(c)(1) (16
- 4 U.S.C. 1536(c)(1)) is amended by striking "Such assess-
- 5 ment may be undertaken" and inserting "Such assessment
- 6 shall be made available to the public, and may be under-
- 7 taken".
- 8 (d) Foreign Species.—Section 7 (16 U.S.C. 1536)
- 9 is amended by adding at the end the following:
- 10 "(q) Foreign Species.—This section shall apply to
- 11 any agency action with respect to any endangered species,
- 12 threatened species, species proposed to be added to a list
- 13 under section 4(c), or candidate species carried out in
- 14 whole or in part, in the United States, in a foreign coun-
- 15 try, or on the high seas.".
- 16 (e) Streamlining and Consolidating Inter-
- 17 AGENCY COOPERATION.—Section 7 (16 U.S.C. 1536) is
- 18 further amended by adding at the end the following:
- 19 "(r) Regulations To Ensure Timely Conclu-
- 20 SION OF CONSULTATIONS.—
- 21 "(1) IN GENERAL.—Within 1 year after the
- date of the enactment of the Endangered Species
- Recovery Act of 1997, the Secretary shall, in co-
- operation with the States, promulgate regulations

1	that will ensure timely conclusion of consultations
2	under this section.
3	"(2) Content.—Regulations under this sub-
4	section shall provide, among other matters, that—
5	"(A) consultations and conferences under
6	this section between the Secretary and a Fed-
7	eral agency shall, to the extent practicable and
8	if approved by the Secretary, encompass a num-
9	ber of similar or related agency actions to be
10	undertaken within a particular geographical
11	range or ecosystem; and
12	"(B) the Secretary shall, to the extent
13	practicable, consolidate requests for consulta-
14	tions or conferences from various Federal agen-
15	cies whose proposed actions may affect endan-
16	gered species, threatened species, or candidate

2	Section 10(a) (16 U.S.C. 1539(a)) is amended to

23	riod and that would jeopardize the continued exist-
24	ence of the species are reasonably foreseeable.
25	"(2) Conservation Plan.—(A) No permit
26	may be issued by the Secretary authorizing any tak-

1	ing referred to in paragraph (1)(B) unless the appli-
2	cant therefor submits to the Secretary a conserva-
3	tion plan in accordance with this paragraph that is
4	based on the best scientific and commercial informa-

15	sult from the permitted activities covered by the
16	plan, including the impacts of modification or
17	destruction of habitat of species authorized to
18	be taken under the permit.
19	"(iv) Objective, measurable biological goals
20	to be achieved for each species covered by the
21	plan.
22	"(v) The conservation measures the appli-
23	cant will implement to minimize and mitigate
24	the impacts specified under clause (iii), includ-
25	ing—

1	"(I) the specific conservation meas-
2	ures for achieving the biological goals of
3	the plan; and
4	"(II) any additional requirements or
5	restrictions or other adaptive management
6	provisions that are necessary to respond to
7	all reasonably foreseeable changes in cir-
8	cumstances that would jeopardize the con-
9	tinued existence of any species covered by
10	the plan, including but not limited to new
11	scientific information and changing envi-
12	ronmental conditions, including natural
13	disasters.
14	"(vi) The reasonably anticipated costs of
15	the measures specified under clause (v).
16	"(vii) Measures the applicant will take to
17	monitor the effectiveness of the plan's conserva-
18	tion measures in achieving the plan's biological
19	goals and impacts on recovery of each species.
20	"(viii) Funding that will be available to the
21	applicant, throughout the term of the plan, to
22	implement the plan, including but not limited to
23	the conservation measures specified in the plan

1	"(ix) Such other matters as the Secretary
2	determines to be necessary or appropriate for
3	purposes of the plan.
4	"(C) The Secretary shall not issue a permit
5	under paragraph (1)(B) for the taking of any spe-
6	cies unless the Secretary finds that the conservation
7	plan submitted for the permit meets all of the re-
8	quirements of this paragraph and finds, after oppor-
9	tunity for public comment with respect to a permit
10	application and the related conservation plan, that—
11	"(i) the taking will be incidental;
12	"(ii) the applicant will minimize and miti-
13	gate the individual impacts and cumulative im-
14	pacts of such taking;
15	"(iii) the activities authorized by the per-
16	mit and conservation plan are consistent with
17	the recovery of the species and will result in no
18	net loss of the value to the species of the habi-
19	tat occupied by the species;
20	"(iv) the applicant has, in accordance with
21	paragraph (8), filed a performance bond or
22	other evidence of financial security to ensure
23	adequate funding for each element of the con-
24	servation plan; and

"(v) the permit contains such terms and conditions as are necessary or appropriate to carry out the purposes of this paragraph and ensure implementation of the conservation plan by the applicant, including but not limited to, such reporting and monitoring requirements as are necessary for determining whether such terms and conditions are being complied with.

"(D)(i) Each permit shall require the permittee to provide to the Secretary, one year after the date of issuance of the permit, and at least every year thereafter during the term of the permit, a complete report on the biological status of the species in the affected area, the impacts of the habitat conservation plan and the permitted action upon the species, and whether the biological goals of the plan are being met.

"(ii) The Secretary shall make reports required under this subparagraph available to the public.

"(E)(i) If necessary to ensure that the permitted action does not jeopardize the continued existence of any species affected by the permitted action, the Secretary shall require a permittee to implement conservation measures in addition to those specified in the plan.

"(ii) The Secretary shall pay the costs of any 1 2 additional conservation measures required under this 3 subparagraph that are in excess of the reasonably 4 anticipated costs specified in the plan. 5 "(3) Review by Secretary.— 6 "(A) The Secretary shall, every three years 7 after the date of approval of a permit applica-8 tion and conservation plan under this section, 9 review and report on the progress of implementation of the terms and conditions of the permit 10 11 and plan and make recommendations on actions 12 necessary to ensure that they do not jeopardize 13 the continued existence of any species, that 14 progress is being made toward achieving the bi-15 ological goals of the plan, and that the require-16 ments of this section and the goals and policies 17 of the Act are carried out. 18 "(B) The Secretary shall annually— 19 "(i) prepare and make publicly avail-20 able a report on the status of all permits 21 reviewed pursuant to this paragraph; and 22 "(ii) publish in the Federal Register a 23 notice of the availability of that report. PERMIT REVOCATION.—The 24 Secretary

shall revoke a permit issued under this section and

1	issue an order suspending activities allowed under
2	the permit that may be reasonably expected to cause
3	a take of any species covered by the permit, if—
4	"(A) the permittee is not in compliance
5	with the terms and conditions of the permit, the
6	requirements of this Act, and the regulations
7	implementing this Act, including any failure by
8	a permittee to substantially comply with the
9	conservation plan required for a permit issued
10	under paragraph (1)(B); or
11	"(B) the level of take authorized by the
12	permit has been exceeded.
13	"(5) Actions by secretary upon failure
14	BY PERMITTEE.—(A) If a permittee defaults on any
15	obligation of the permittee under a conservation plan

18	retary shall undertake actions to conserve each spe-
19	cies covered by the plan and permit.
20	"(B) For actions required under subparagraph
21	(A) with respect to a default by a permittee, the
22	Secretary may use—
23	"(i) the proceeds of the performance bond
24	or other financial security under paragraph (8)
25	provided by the permittee; and

1	"(ii) amounts in the Habitat Conservation
2	Fund under paragraph (9).
3	"(6) Low effect, small scale plans.—(A)
4	The Secretary shall develop and implement a
5	streamlined application and approval procedure for a
6	permit under paragraph (1)(B) and related con-
7	servation plan that the Secretary determines to be a
8	low effect, small scale plan.
9	"(B) A permit and related conservation plan
10	may be treated as a low effect, small scale permit
11	and plan if they meet all of the following criteria:
12	"(i) The permitted action is expected to be
13	of less than 5 years' duration.
14	"(ii) The conservation plan is applicable to
15	fewer than 5 acres.
16	"(iii) The affected acreage is not adjacent
17	to other lands that have been the subject of a
18	permit issued under this section within the pre-
19	ceding five years to the same person, or as part
20	of the same project.
21	"(iv) The permitted action is not part of a
22	single larger project that will have additional
23	impacts on the endangered species or threat-

1	"(v) The Secretary determines the plan

5	"(vi) The permitted action is not related to
6	other actions that will have additional impacts
7	on the endangered or threatened species. For
8	purposes of this clause, actions shall be consid-
9	ered related if they—
10	"(I) automatically trigger other ac-
11	tions which may affect endangered species
12	or threatened species;
13	"(II) cannot or will not proceed unless
14	other actions are taken previously or si-
15	multaneously; or
16	"(III) are interdependent on parts of
17	a larger action and depend on the larger
18	action for their justification.
19	"(C)(i) The Secretary shall monitor the imple-
20	mentation and results of low effect, small scale per-
21	mits and conservation plans to ensure that they do
22	not jeopardize the continued existence of any endan-
23	gered species or threatened species.
24	"(ii) If the Secretary determines that additional
25	requirements or restrictions are required to ensure

- that actions authorized by a low effect, small scale conservation plan do not jeopardize the continued existence of any species determined to be an endangered species or threatened species after the plan was approved, the Secretary shall require appropriate modifications to the plan to establish those requirements or restrictions.
 - "(iii) The Secretary shall pay all costs of implementing additional requirements or restrictions required under clause (ii).
 - "(D) The permittee for which a low effect, small scale permit and conservation plan is approved under this paragraph shall not be required to provide a performance bond or other financial security under paragraph (8).
 - "(7) MONITORING.—The Secretary shall monitor the implementation and results of all conservation plans approved under this subsection to ensure they do not jeopardize the continued existence of any endangered species or threatened species.
 - "(8) Performance Bonds.—(A) After the approval of an incidental take permit under paragraph (1)(B) and associated conservation plan in accordance with this subsection, but before such permit is issued, the applicant shall—

1	"(i) file with the Secretary a performance
2	bond payable to the United States, and condi-
3	tional upon faithful performance of all the re-
4	quirements of the permit; or
5	"(ii) deposit other forms of financial secu-
6	rity, payable to the United States, in a form
7	and manner approved by the Secretary, and
8	conditional upon such faithful performance,
9	having a cash or market value, as applicable,
10	equal to or greater than the amount of a per-
11	formance bond otherwise required under clause
12	(i).
13	"(B) The amount of the bond or deposit of
14	other financial security required for each permit—
15	"(i) shall be determined by the Secretary;
16	"(ii) shall be based upon the mitigation re-
17	quirements needed to meet the biological goals
18	of the conservation plan; and
19	"(iii) shall be sufficient to ensure the com-
20	pletion of all conservation measures to be imple-
21	mented by the permittee under the conservation

24	"(C) In the case of a bond or deposit of other
25	financial security required for a large-scale conserva-

- tion plan (as that term is defined in paragraph (11)), or a conservation plan for which the reasonably foreseeable costs may be prohibitive, the Secretary may authorize the use of—
 - "(i) phased bonds or deposits, by which the permittee may divide the area or actions covered by the conservation plan into discrete sections and execute a separate bond or deposit for each section before undertaking any action on that section; or
 - "(ii) adjusted bonds or deposits, through which the amount of the bond or deposits required and the terms of acceptance of the bond or deposit shall be adjusted by the Secretary from time to time as the extent of actions that affect endangered species or threatened species increases or decreases.
 - "(D) The bond or deposits shall be executed by the permittee and a corporate surety or depository, respectively.
 - "(E)(i) The permittee may file a request with the Secretary for the release of all or any part of a performance bond or deposit of any other financial security required under this paragraph. Within 30 days after any application for release has been filed

- with the Secretary, the Secretary shall file notice of such application in the Federal Register and provide opportunity for public comment before making a decision under clause (ii).
- "(ii) Upon receipt of the request, the Secretary shall within 30 days conduct a review of the implementation of the conservation plan to determine whether the requirements of the plan have been fully implemented, the plan has achieved its biological goals, and no further action is needed to ensure that the permitted action is not jeopardizing the existence of the species covered by the plan.
- "(iii) The Secretary shall notify the permittee in writing of the decision of the Secretary to release or not to release all or part of the bond or deposit, within 90 days after the filing of the request. If the Secretary does not release any portion of the bond or deposit, the Secretary shall notify the permittee in writing, stating the reasons the portion was not released and recommending corrective actions necessary to secure that release.
- "(9) Habitat Conservation Plan fund.—
 (A) There is established in the Treasury a separate account to be known as the 'Habitat Conservation

1	Plan Fund' (in this paragraph referred to as the
2	'fund'). The fund shall consist of—
3	"(i) donations to the fund;
4	"(ii) appropriations to the fund;
5	"(iii) amounts received by the United
6	States as fees charged for permits under this
7	section;
8	"(iv) amounts received by the United

11	"(v) the proceeds of performance bonds

5	"(10) Multiple Landowner, multispecies
6	PLANNING.—(A) The Secretary shall encourage the
7	development of multiple landowner, multispecies con-
8	servation plans, that—
9	"(i) make a significant contribution to the
10	recovery of an endangered species or threatened
11	species;
12	"(ii) rely on the best available scientific in-
13	formation;
14	"(iii) rely, to the maximum extent prac-
15	ticable, on ecosystem planning; and
16	"(iv) maintain the well-being of other spe-
17	cies located within the planning area.
18	"(B)(i) To encourage the development of such
19	plans, the Secretary shall cooperate to the maximum
20	extent practicable with States and local governments

"(C) A permit under subparagraph (B)(ii) may authorize the State, local government, or group of local governments to issue incidental take certificates to landowners that authorize takings under the authority of the permit within the jurisdiction of the State, local government, or group of local governments, if—

"(i) the State, local government, or group of local governments meets the performance bond or other financial security requirements under paragraph (8) with respect to all such certificates, or each certificate is effective only after the landowner to whom the certificate is issued has met those requirements with respect to the certificate;

"(ii) the State, local government, or group of local governments ensures that all incidental take certificates issued under the permit are consistent with the permit and approved habitat conservation plan;

"(iii) the State, local government, or group of local governments provides adequate public

 - "(D) Upon receipt of a request for agency involvement in the development of a large-scale conservation plan, the Secretary shall invite independent scientists with expertise on species that may be affected by the plan to provide input.
 - "(E) For the purposes of this paragraph:
 - "(i) The term 'agency involvement' means any role played by the Secretary in the development of a conservation plan pursuant to paragraph (2)(A).
 - "(ii) The term 'large-scale conservation plan' means a conservation plan that would cover a significant portion of the range of a threatened species, endangered species, candidate species, or species proposed for listing under section 4.
 - "(iii) For purposes of this subparagraph, an independent scientist is a scientist that meets that criteria set forth in clauses (i) and (ii) of section 4(f)(D).

14	"(B) files such agreement with the Sec-
15	retary, and
16	"(3) each person entering into such agreement
17	consents to the application of subsection (c),
18	then, for purposes of the tax imposed by section 2001,
19	the value of the taxable estate shall be determined by de-
20	ducting from the value of the gross estate an amount
21	equal to the value of such real property.
22	"(b) Endangered Species Conservation Agree-
23	MENT.—For purposes of this section, the term 'endan-
24	gered species conservation agreement' means, with respect
25	to any real property, any endangered species conservation
26	agreement (as defined in section 5(c) of the Endangered

10	est in any property subject to an endan-
11	gered species conservation agreement,
12	"(ii) there is a material breach by any
13	person who holds an interest in such prop-

15	"(iii) such agreement terminates,
16	then there is hereby imposed an additional es-
17	tate tax.
18	"(B) Amount of Tax.—The amount of
19	the tax imposed by subparagraph (A) with re-
20	spect to any interest shall be the amount which
21	bears the same ratio to the fair market value of
22	such interest (as of the date of the event caus-

1	"(I) what would have been the
2	estate tax liability but for subsection

10	'estate tax liability' means the tax imposed by
11	section 2001 reduced by the credits allowable
12	against such tax.
13	"(C) Exception if transferee as-
14	SUMES OBLIGATIONS OF TRANSFEROR.—Sub-
15	paragraph (A)(i) shall not apply to a disposition
16	if the transferee enters into a binding written
17	agreement—
18	"(i) to assume the obligations imposed
19	on the transferor under the endangered
20	species conservation agreement,
21	"(ii) to assume personal liability for
22	any tax imposed under subparagraph (A)
23	with respect to—
24	"(I) any future disposition or
25	breach by such transferee, and

1	"(II) the termination of the
2	agreement if such transferee holds an
3	interest in such property as of such
4	termination, and
5	"(iii) to provide written notice to the
6	Secretary who entered into the endangered
7	species conservation agreement that the
8	transferee has assumed such obligations
9	and liabilities.
10	"(2) DUE DATE OF ADDITIONAL TAX.—The tax
11	imposed by paragraph (1) shall become due and pay-
12	able on—
13	"(A) in a case described in paragraph
14	(1)(A)(i), the day that is 6 months after the
15	date of the disposition, and
16	"(B) in a case described in clause (ii) or
17	(iii) of paragraph (1)(A), on April 15 of the cal-
18	endar year following the calendar year in which
19	there is a finding under section $5(c)(2)$ of the
20	Endangered Species Act of 1973 that the event
21	described in such clause has occurred.
22	"(d) Statute of Limitations.—If a taxpayer in-
23	curs a tax liability pursuant to subsection (c), then—

"(2) to the Secretary of Commerce for entering into cooperative agreements under section 6 with States and Indian Tribes, \$5,000,000 for each of fiscal years 1999, 2000, 2001, and 2002.".
