A BILL

For the relief of Farah Sirmanshahi, Sepandan Farnia, and
Farbod Farnia.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR FARAH**
4 **SIRMANSHAHI, SEPANDAN FARNIA, AND**
5 **FARBOD FARNIA.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)
7 and (b) of section 201 of the Immigration and Nationality
8 Act, Farah Sirmanshahi, Sepandan Farnia, and Farbod
9 Farnia shall each be eligible for issuance of an immigrant
10 visa or for adjustment of status to that of an alien lawfully
11 admitted for permanent residence upon filing an applica-

1 tion for issuance of an immigrant visa under section 204
2 of such Act or for adjustment of status to lawful perma-
3 nent resident.

4 (b) ADJUSTMENT OF STATUS.—If Farah
5 Sirmanshahi, Sepandan Farnia, or Farbod Farnia enters
6 the United States before the filing deadline specified in
7 subsection (c), he or she shall be considered to have en-
8 tered and remained lawfully and shall, if otherwise eligible,
9 be eligible for adjustment of status under section 245 of
10 the Immigration and Nationality Act as of the date of the
11 enactment of this Act.

12 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
13 FEES.—Subsections (a) and (b) shall apply only if the ap-
14 plication for issuance of an immigrant visa or the applica-
15 tion for adjustment of status is filed with appropriate fees
16 within 2 years after the date of the enactment of this Act.

17 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—
18 Upon the granting of an immigrant visa or permanent res-
19 idence to Farah Sirmanshahi, Sepandan Farnia, and
20 Farbod Farnia, the Secretary of State shall instruct the
21 proper officer to reduce by 3, during the current or next
22 following fiscal year, the total number of immigrant visas
23 that are made available to natives of the country of the
24 aliens' birth under section 203(a) of the Immigration and
25 Nationality Act or, if applicable, the total number of immi-

- 1 grant visas that are made available to natives of the coun-
- 2 try of the aliens' birth under section 202(e) of such Act.
