A BILL

To provide for the approval of a petition pending at the Food and Drug Administration to allow the use of low-dose irradiation to pasteurize red meat, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Hamburger Safety Act
- 5 of 1997".

1 SEC. 2. DISCLOSURE OF IRRADIATION.

- 2 Chapter IV (21 U.S.C. 341 et seq.) is amended by
- 3 inserting after section 403B the following:
- 4 "DISCLOSURE
- 5 "Sec. 403C. (a) No provision of section 201(n),
- 6 403(a), or 409 shall be construed to require on the label
- 7 or labeling of a food a separate radiation disclosure state-
- 8 ment that is more prominent than the declaration of ingre-
- 9 dients required by section 403(i)(2).
- 10 "(b) In this section, the term 'radiation disclosure
- 11 statement' means a written statement that discloses that
- 12 a food or a component of the food has been intentionally
- 13 subject to radiation.".
- 14 SEC. 3. FDA ACTION ON PETITION.
- 15 The Secretary of Health and Human Services shall,
- 16 not later than 30 days after the date of the enactment
- 17 of this Act, appove the petition of the Isomedix Corpora-
- 18 tion submitted June 30, 1994 under section 409(b)(1) of
- 19 the Federal Food, Drug, and Cosmetic Act.
- 20 SEC. 4. LOW-DOSE IRRADIATION INFORMATION.
- 21 Chapter IV of the Food, Drug, and Cosmetic Act is
- 22 amended by adding at the end the following:
- 23 "LOW-DOSE IRRADIATION INFORMATION
- "Sec. 414. A commercial establishment serving pre-
- 25 pared meat and poultry shall make available information
- 26 to patrons about whether the meat and poultry being

- 1 served has been treated with low-dose radiation. The infor-
- 2 mation shall be provided in a manner that the establish-
- 3 ment deems appropriate to provide such information to

4 patrons.".
