A BILL

To amend the Harmonized Tariff Schedule of the United States to extend to certain fine jewelry certain trade benefits of insular possessions of the United States.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the additional U.S. notes to chapter 71 of the Har-
- 4 monized Tariff Schedule of the United States are amended
- 5 by adding at the end the following new note:
- 6 "3.(a) Notwithstanding any other provision in additional
- 7 U.S. note 5 to chapter 91, any article of jewelry pro-
- 8 vided for in heading 7113 which is the product of
- 9 the Virgin Islands, Guam, or American Samoa (in-

- 1 cluding any such article which contains any foreign
- 2 component) shall be eligible for the benefits provided
- 3 in paragraph (h) of additional U.S. note 5 to chapter
- 4 91, subject to the provisions and limitations of that
- 5 note and of paragraphs (b), (c), and (d) of this note.
- 6 "(b) Nothing provided for in this note shall result in an
- 7 increase or a decrease in the aggregate amount re-
- 8 ferred to in paragraph (h)(iii) of, or quantitative limi-
- 9 tation otherwise established pursuant to the require-
- ments of, additional U.S. note 5 to chapter 91.
- 11 "(c) Nothing provided for in this note shall be construed
- to permit a reduction in the amount available to
- watch producers under paragraph (h)(iv) of addi-
- tional U.S. note 5 to chapter 91.
- 15 "(d) The Secretary of Commerce and the Secretary of the
- 16 Interior shall issue such regulations, not inconsistent
- with the provisions of this note and additional U.S.
- note 5 to chapter 91, as they determine necessary to
- carry out their respective duties under this note. Such
- regulations shall not be inconsistent with substantial
- 21 transformation requirements established by the Unit-
- 22 ed States Customs Service but may define the cir-
- cumstances under which articles of jewelry shall be
- deemed to be 'units' for purposes of the benefits, pro-

- 1 visions, and limitations of additional U.S. note 5 to
- 2 chapter 91.".
